Henrico Police Seek Public's Assistance to Identify Auto-Pedestrian Victim

(Henrico County, Va.) – Henrico Police is seeking the public's assistance to identify the victim in an auto-pedestrian crash.

On December 31, 2024 at approximately 9:31 p.m., Henrico Police and Henrico Fire responded to a call for a pedestrian who was hit by a vehicle at the intersection of W. Broad Street and Carousel Lane. The victim was transported to an area hospital with life-threatening injuries.

The preliminary investigation indicates the victim, a female, was running westbound across West Broad Street when she was struck by a vehicle. The driver remained on-scene and is cooperating with police. Alcohol nor speed appear to be factors in the crash for the driver.

The victim is currently unconscious, and Henrico Police is seeking the public's assistance to identify them to contact their family:

- Race: White
- Sex: Female
- Hair: Brown and curly
- Height: 5'2"-5'4"
- Weight: 120-140 pounds
- Age: 20s
- Wearing: Black Carhart sweatshirt, Light blue Underarmor shoes
- Last seen: W. Broad St. and Carousel Ln.

Chesterfield County Woman Charged in Connection to NICU Investigation

Update 2 (01/03/25):

(Henrico County, Va.) – Henrico Police has arrested and charged a Chesterfield County woman in connection to an ongoing investigation involving a Henrico Doctors' Hospital's Neonatal Intensive Care Unit (NICU).

During the course of the investigation, detectives identified **Erin Elizabeth Ann Strotman, 26, of Chesterfield County**, as a suspect in this case. Ms. Strotman faces charges of malicious wounding and felony child abuse in connection to an incident that occurred in November 2024.

Currently, the Henrico County Police Division is utilizing all available resources to ensure a thorough investigation into this matter. This involves reviewing dozens of videos from inside the NICU. As previously mentioned, detectives are re-examining the 2023 and 2024 cases as part of this broader investigation.

Henrico Police Addresses Editorial Social Media Videos and Calls into the DEC

Update 3 (01/07/25):

(Henrico County, Va.) – Henrico Police is aware of editorial social media videos discussing the Henrico Doctors' Hospital NICU investigation. These individuals in the video claim the victims were targeted by the suspect on account of their race. The preliminary investigation indicates this information is not factual.

As with any investigation, the Henrico County Police Division is utilizing all available resources to ensure a thorough investigation into this matter. This involves reviewing dozens of videos from inside the NICU. Due to the sensitive nature of these cases, specific information including race/gender/types of injuries, etc. is not able to be released; detectives do not want to compromise the investigation moving forward.

"We understand the feelings and emotions this investigation has generated for our community members and beyond," said **Henrico Chief of Police Eric D. English**. "We kindly request patience as our detectives work to investigate every piece of evidence in connection to these cases. The Henrico County Police Division is working seamlessly with our partners, including the Henrico County Commonwealth's Attorney's Office, to investigate these cases; we will not be deterred."

Additionally, these videos direct citizens to contact the Henrico County Department of Emergency Communications (DEC) to share their thoughts and information on the investigation. Henrico Police Investigate Fatal Two-Vehicle Crash

(Henrico County, Va.) – Henrico Police is investigating a fatal two-vehicle crash that occurred in Henrico's Varina District.

On Saturday, January 25, 2025, at approximately 5:41 p.m., Henrico Police responded to the intersection of Williamsburg Road (Rt. 60) and Whiteside Road for the report of a two-vehicle crash.

Once on scene, officers located a Chevrolet Tahoe and a Nissan Altima that had collided. The two occupants of the Tahoe were transported to an area hospital with non-life-threatening injuries. The driver of the Nissan Altima was also transported to an area hospital where they later succumbed to their injuries sustained from the crash.

Henrico Police has identified the deceased victim as **Justin Lee Butler Jr., 21, of Henrico.**

The preliminary investigation indicates Mr. Butler was traveling westbound on Williamsburg Road when the driver of the Chevrolet Tahoe, who was driving south on Whiteside Road, entered the intersection hitting the front side of Mr. Butler's Nissan. Mr. Butler was not wearing a seatbelt at the time of the crash. Crash Team Investigators are working to determine any contributing factors behind this crash.

Rabies Clinic Scheduled for February

(Henrico County, Va.) – The Henrico County Police Division will hold [a rabies vaccination](#) clinic for dogs and cats from **9 a.m. to noon on Saturday, February 22** at the Henrico County Western Government Complex (4301 E. Parham Road).

Pet owners must register and pay at the cashier's office in the Administration Building before seeing a veterinarian on the first level of the adjacent parking deck.

Each vaccine costs \$20 and must be paid in cash. A rabies tag and a certificate of inoculation are included. Pets from all localities are welcome. Cats must be in carriers.

Under Virginia law, dogs and cats four months of age and older must be vaccinated for rabies.

Henrico dog licenses will also be available for \$10. Licenses are valid for the life of the animal while the owner lives in Henrico and its rabies vaccinations are kept current. **Officers will be available to discuss license and vaccination requirements.**

Additional Arrests Made in Connection To Fall 2024 Vandalism Spree

UPDATE 2:

(Henrico County, Va.) – Henrico Police has made two additional arrests in connection with a multi-jurisdiction vandalism spree that occurred in October and November 2024.

During the investigation, detectives identified brothers **Dakota Eagleheart Winters, 27**, and **Sequoiya Windwalker Winters, 23, of Lunenburg, Va.** These two face the following charges:

- **Dakota Eagleheart Winters** (Arrested on 01.30.25)
 - 15 Felony Counts of Vandalism
- **Sequoiya Windwalker Winters** (Arrested on 02.03.25)
 - 9 Felony Counts of Vandalism
 - 6 Misdemeanors (Vandalism-related)

These new charges are related to crimes that occurred in the Sandston area of Henrico County in mid-October as well as the other areas of Henrico in November. **Aaron James Webb, 23, of Prince George**, who was previously arrested back on December 20, also faces additional charges related to October's vandalism spree.

"Henrico Police will not tolerate acts of vandalism against our neighbors and the businesses that operate in Henrico County," said **Henrico Chief of Police Eric D. English**. "We acknowledge that our neighboring localities fell victim to this senseless crime spree. We are hopeful that the arrests and charges made during this investigation will bring a sense of relief and accountability for the victims of these incidents."

Henrico Police would like to once again thank Colonial Heights Police, Richmond City Police, VCU Police, Prince George County Police, The Henrico County Commonwealth's Attorney and Richmond City Commonwealth's Attorney for their assistance and partnership during this ongoing investigation.

UPDATE 1 (12.20.24):

(Henrico County, Va.) – Henrico Police has arrested a Prince George County man in connection to several vandalism cases in mid-November.

On Friday, December 20, 2024, during a multi-agency operation, **Aaron James Webb, 23, of Prince George**, was taken into custody at his residence.

Mr. Webb has been charged with 10 felony counts of vandalism and 11 misdemeanors (vandalism-related) in Henrico County for the incidents that occurred overnight November 15-16. Currently, detectives in the Criminal Investigations Section are continuing their investigation into the Sandston vandalisms in October.

Additionally, evidence gathered as part of this operation indicates Mr. Webb may have been involved in several other crimes in neighboring jurisdictions including the City of Richmond, Virginia Commonwealth University (VCU), Colonial Heights and Prince George County.

“We appreciate our community members’ patience as our detectives worked as quickly and thoroughly as possible to investigate these vandalisms that occurred across the county,” said **Henrico Police spokesperson Karina Bolster**. “The safety and security of our residents is our mission as an agency, one that will continue throughout the holiday season.”

Henrico Police would like to thank the Prince George County Police Department, Colonial Heights Police Department, Richmond Police Department and VCU Police for their assistance in taking Mr. Webb into custody. Additionally, we appreciate the collaboration and coordination of these agencies throughout this investigation.

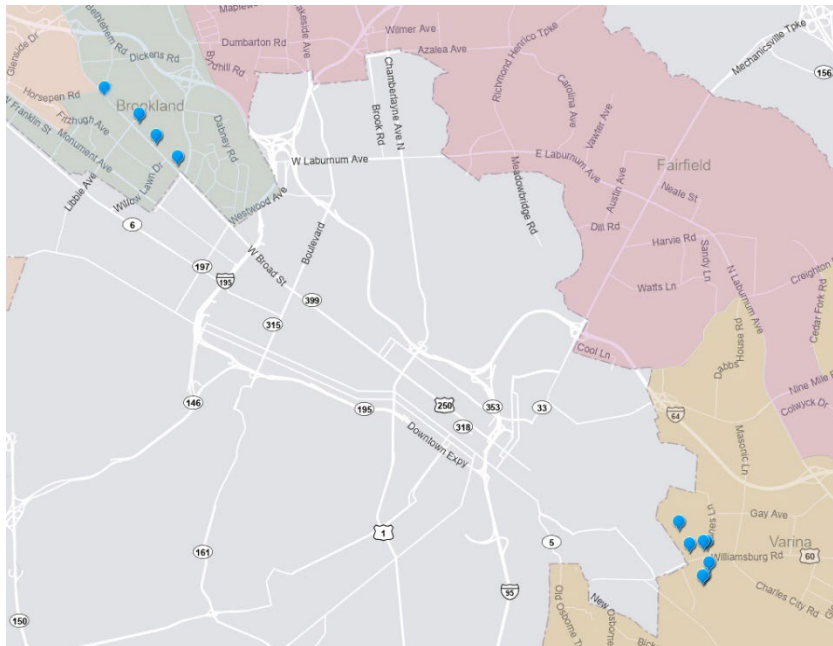

Henrico Police Investigates Charles City Road Homicide

(Henrico County, Va.) – Henrico Police is investigating its first homicide of 2025 which occurred in the Varina District.

On Tuesday, February 4, 2025, at approximately 12:09 a.m., Henrico Police responded to the 5000 block of Charles City Road for a reported medical emergency. Once on scene, officers located an adult male in the driver's seat of a vehicle unresponsive. During an assessment of the scene, officers located obvious signs of trauma on the victim; he was pronounced deceased at the scene.

Henrico Police has identified the victim as **Chad Michael Young, 39, of Henrico**. Detectives within the Criminal Investigations Section continue to investigate this incident and what occurred. Henrico Police will work alongside the Office of the Chief Medical Examiner to determine the cause of death.

Henrico Police Investigate Fatal Incident off Pathfinder Circle

(Henrico County, Va.) – Henrico Police is investigating a fatal incident that occurred in Henrico's Tuckahoe District.

On February 13, 2025, at approximately 11:34 p.m., Henrico Police and Henrico Fire responded to the 2300 block of Pathfinder Circle for a reported medical emergency. Once on scene, officers located an adult woman in the driveway with obvious signs of trauma. Officers provided life-saving measures until first responders with Henrico Fire were able to transport the woman to an area hospital with critical injuries. The woman succumbed to her injuries on February 18.

Henrico Police have identified the victim as **Anastasia Xyderis Flegas, 52, of Henrico.**

The preliminary investigation indicates Ms. Flegas had gone outside to move a vehicle when she stepped out of the moving vehicle and was hit by the car door, causing her to fall to the ground. The vehicle then proceeded to roll over her, causing significant injuries.

Henrico Police Investigates Fatal Pedestrian Crash on Monument Avenue

(Henrico County, Va.) – Henrico Police is now investigating this incident as a fatal pedestrian crash.

On February 20, 2025, at approximately 8:40 p.m., Henrico Police and Henrico Fire responded to the 6300 block of Monument Avenue for the report of a pedestrian struck by a vehicle. Officers arrived on scene and located an adult male lying in the roadway. The victim was transported to an area hospital with life-threatening injuries. On Tuesday, February 25, 2025, the victim succumbed to their injuries sustained from the crash.

Henrico Police Crash Investigators have identified the victim as **Shawn Quentin Ford, 43, City of Richmond.**

The preliminary investigation indicates Mr. Ford was walking in the right westbound lane Monument Avenue when he was struck by a Chevrolet Equinox. The driver of the Equinox stayed on scene and cooperated with investigators. Crash Team Investigators continue to investigate the cause of the crash, but speed, alcohol and drugs are not believed to be factors related to this crash.

Henrico Police Investigate Deadly Hit-and-Run Crash on Airport Drive

UPDATE 2:

(Henrico County, Va.): Henrico Police continues to investigate a deadly hit-and-run crash that occurred over the weekend in Henrico's Varina Magisterial District.

On Saturday, March 22, 2025, around 2:12 a.m., Henrico Police responded to the intersection of Airport Drive and Audubon Drive for a reported two-vehicle crash. Once on scene, officers located a Toyota Yaris and a Cadillac CTS with significant damage. The adult male driver of the Toyota was pronounced dead at the scene. An adult woman, also in the Toyota, was transported to an area hospital with life-threatening injuries.

Henrico Police Crash Team Investigators have identified the victim as **Luis Fernando Cac Caal, 29, of Sandston**. The female victim remains hospitalized in critical condition.

The preliminary investigation indicates the Cadillac CTS was involved in a pursuit which originated on I-64 west in New Kent County. The pursuit traveled into Henrico County where the crash occurred between the Cadillac and Toyota. The occupants inside the Cadillac ran from the scene following the collision.

In the hours after the crash a person of interest was identified. **Tony Lamont Roberts, 18, of Hopewell**, was taken into custody on March 22 by the Hopewell Police Department. Mr. Roberts currently faces a number of charges in connection to the crash which include:

- Felony Hit-and-Run
- Misdemeanor Eluding
- Obstruction of Justice
- Possession of a Firearm by a felon
- Possession of a Firearm while under a protective order
- Possession of an extended magazine

Henrico Police is grateful for the quick and collaborative efforts of several law enforcement agencies who assisted with this investigation from the onset. Those agencies include the New Kent County Sheriff's Office, Virginia State Police, Hopewell and Petersburg Police Departments. The New Kent County Sheriff's Office will handle the pursuit investigation while Henrico Police investigates the crash.

Henrico Police Encounter First Rabies case of 2025

The raccoon was submitted to the State Lab and tested positive for rabies. Because there was potential contact between the dogs and the raccoon, the dogs will be quarantined on the owner's property. There were no additional animal or human exposures reported. This is the first confirmed rabies case in Henrico County for 2025.

The Henrico Police Animal Protection Unit reminds everyone to keep their pets' rabies vaccinations current to ensure the safety of their pets and our community. Henrico County offers rabies vaccination clinics throughout the year. The [next rabies clinic](#) is scheduled for Saturday, May 17th, 2025, from 9:00 a.m. to 12:00 p.m., at the Henrico County Western Government Center, located on Parham Road. Henrico Police Makes Arrest Following Assault and Pursuit

(Henrico County, Va.): Henrico Police have arrested and charged a Henrico man in connection to Sunday's assault which led to a pursuit ending in the City of Richmond.

On Sunday, April 13, 2025, at approximately 2:25 p.m., Henrico Police were dispatched to the intersection of Reynolds Road and Howard Street for the report of a stabbing. When officers arrived on scene, they located an adult female victim with an injury to her neck. Officers immediately began to render aid and with the assistance of Henrico Fire, transported her to an area hospital for treatment of life-threatening injuries, where she remains hospitalized.

Officers were quickly able to locate the suspect's vehicle in the 4700 block of Laburnum Avenue. A traffic stop was attempted; however, the driver did not stop. A pursuit was initiated that continued towards the City of Richmond. During the pursuit an adult female exited the vehicle while the suspect car was in motion. Officers located the adult female who was then transported to an area hospital by Richmond Ambulance Authority with non-life-threatening injuries.

The pursuit continued into the City of Richmond where the driver of the suspect vehicle crashed at the intersection of 7th Street and Route 360. A brief foot pursuit ensued before officers were able to detain the suspect. Officers then checked the suspect's vehicle and located a toddler (male) in the back seat. The child was transported to an area hospital for treatment of minor injuries.

The suspect has been identified as **Tyler Renard Robinson-Thomas, 30, of Henrico**. He has been charged with the following;

- **Felony Stabbing**
- **Felony Elude**
- **Felony Child Endangerment**

(Henrico County, Va.): Henrico Police is investigating a homicide which occurred in the Fairfield Magisterial District over the weekend.

On Saturday, April 26, 2025, around 2:39 a.m., Henrico Police responded to the 2800 block of Fairfield Avenue for a reported shooting. Once on scene, officers located an adult male on the ground with an apparent gunshot wound. Life-saving measures were taken until Henrico Fire transported him to an area hospital for treatment; he later died from his injuries.

(Henrico County, Va.) – The Henrico County Police Division will hold [a rabies vaccination](#) clinic for dogs and cats from **9 a.m. to noon on Saturday, May 17** at the Henrico County Western Government Complex (4301 E. Parham Road).

Pet owners must register and pay at the cashier's office in the Administration Building before seeing a veterinarian on the first level of the adjacent parking deck.

Each vaccine costs \$20 and must be paid in cash. A rabies tag and a certificate of inoculation are included. Pets from all localities are welcome. Cats must be in carriers.

Under Virginia law, dogs and cats four months of age and older must be vaccinated for rabies.

Henrico dog licenses will also be available for \$10. Licenses are valid for the life of the animal while the owner lives in Henrico and its rabies vaccinations are kept current. **Officers will be available to discuss license and vaccination requirements.**

Once on scene, officers located an adult male with an apparent gunshot wound. Life-saving measures were immediately provided until Henrico Fire was able to transport him to an area hospital with life-threatening injuries. On Friday, May 2, 2025, the victim died from his injuries.

Second Suspect Charged in Deadly Hit-and-Run Crash on Airport Drive

(Henrico County, Va.): Henrico Police continues to search for additional people of interest in a deadly hit-and-run crash following the arrest of a second suspect.

On the evening of May 19, 2025, **Samarion Ty'shon Seymour, 20, of Norfolk**, turned himself into the Petersburg Bureau of Police. Mr. Seymour is the second suspect arrested in connection with the March 22 hit-and-run crash.

During the course of the investigation, Henrico Police and investigators from the New Kent County Sheriff's Office determined Mr. Seymour was the driver of the Cadillac CTS that crashed into the Toyota killing **Luis Fernando Cac Caal, 29, of Sandston**. The female victim who was hospitalized has since been released.

Mr. Seymour faces the following charges:

- Manslaughter
- Felony Hit-and-Run
- Felony Eluding

Additional charges are forthcoming.

Henrico Police Earns Distinguished TRI-ARC Reaccreditation

(Henrico County, Va.): The Henrico County Police Division was awarded TRI-ARC reaccreditation by the [Commission on Accreditation for Law Enforcement Agencies \(CALEA\)](#). To date, the Division is one of only 39 agencies worldwide to receive TRI-ARC reaccreditation.

CALEA was founded in 1979 through a collaborative partnership between the **International Associations of Chiefs of Police**, the **National Organization of Black Law Enforcement Executives**, the **National Sheriff's Association**, and the **Police Executive Research Forum**. Its **TRI-ARC Award** was created to recognize agencies concurrently holding all three CALEA Accreditation Awards: Law Enforcement, Public Safety Communications, and Public Safety Training Academy.

In 2015, having been accredited in Law Enforcement by CALEA since 1987, Henrico Police set out to expand its accreditation. On March 25, 2017, after completing an eighteen-month self-assessment, on-site CALEA assessments, and appearing before the CALEA Board of Commissioners, the Division's Law Enforcement, Basic Training Academy and Emergency Communications Center were each accredited and Henrico Police was awarded TRI-ARC accreditation. At the time, the Division was only the 17th law enforcement agency worldwide to attain this distinction and just the 16th in the United States.

As part of a four-year reaccreditation cycle, the Division's TRI-ARC reaccreditation assessment began in October 2024. Assessors performed file reviews, evaluated the Division's compliance with CALEA standards, conducted staff interviews and reviewed public-comment via a survey. On March 22, 2025, following a hearing before the CALEA Board of Commissioners, the Division's Law Enforcement, Training Academy and Emergency Communications Center were each awarded reaccreditation, earning Henrico Police the prestigious TRI-ARC Award once again – one of only 39 agencies worldwide to achieve this status to date.

"Maintaining TRI-ARC accreditation reflects the Division's unwavering commitment to professionalism and accountability," said **Henrico Chief of Police Eric English**. "This achievement is a testament to the 800+ men and women of the Division who carry out these standards every day in service to our community."

The Division will be assessed for reaccreditation in 2029, at which time it must demonstrate continuous adherence to the standards set forth by CALEA to maintain TRI-ARC accreditation.

Second Rabies Case Confirmed in Henrico

(Henrico County, Va.): On Sunday, June 8, 2025, Henrico Police responded to the 8700 block of Butterfield Road in the Tuckahoe district of Henrico County for the report of a potential rabies exposure involving a resident and a raccoon.

The resident sustained multiple scratch and bite marks when the raccoon entered their yard, and sought immediate medical attention following the incident.

The raccoon was captured and submitted to the State Lab, where it tested positive for rabies. There were no additional animal or human exposures reported. This is the second confirmed rabies case in Henrico County for 2025.

The Henrico Police Animal Protection Unit reminds everyone to keep their pets' rabies vaccinations current to help prevent the spread of disease in our community. Henrico County offers rabies vaccination clinics throughout the year. The [next rabies clinic](#) is scheduled for Saturday, August 16 from 9 a.m. to noon at the Western Government Center, 4301 E. Parham Rd. Vaccinations cost \$20 per pet and are cash only. Additional rabies clinic dates can be found on the [Henrico County Animal Shelter's page](#).

Please report abnormal wildlife behavior and any possible rabies exposures to Henrico Police by calling 804-501-5000. If there is any suspicion that a person may have been exposed to rabies, seek immediate medical attention; rabies is fatal if left untreated.

Henrico Police Investigates Fatal Patterson Avenue Pedestrian Crash

UPDATE 1:

(Henrico County, Va.) – Henrico Police is investigating a deadly pedestrian crash that occurred overnight in the Tuckahoe Magisterial District.

On Wednesday, September 3, 2025, around 11:55 p.m., Henrico Police responded to the area of Patterson Avenue and Westhampton Glen Drive for a reported pedestrian crash. Once on scene, officers located a Nissan Altima and two adult pedestrians. An adult female pedestrian was transported to an area hospital with life-threatening injuries where she later died.

Henrico Police Crash Investigators have identified the pedestrian as **Alexandria Current, 25, of Oklahoma.**

The preliminary investigation indicates Ms. Current and another adult male attempted to cross the westbound lanes of Patterson Avenue ahead of a Nissan Altima also traveling westbound. The male avoided being hit, but Ms. Current was struck by the vehicle. The driver of the Nissan remained on scene and is cooperating with the investigation. UPDATE 2:

(Henrico County, Va.) – Henrico Police continues to investigate a fatal pedestrian crash that occurred at the intersection of Williamsburg Road and S. Laburnum Avenue.

Henrico Police Crash Investigators have identified the victim as **Phillip Andrew McBride, 37, of Henrico**. The adult male driver of the tractor-trailer who was transported to the hospital with life-threatening injuries has since been released.

The preliminary investigation now indicates the driver of the tractor-trailer, which was hauling a concrete slab, ran through a red light as it was traveling east on Williamsburg Road. A small straight-truck hauling propane on S. Laburnum Avenue traveled into the intersection with a “green light” and collided with the tractor-trailer. The collision caused the tractor-trailer driver to overcorrect, jackknife and flip over on its side, striking the male pedestrian who was on the sidewalk spinning a sign for an area business. Henrico Police Makes Arrests in Illegal Vape Shop Operations

(Henrico County, Va.) – The Henrico County Police Division, in partnership with county leaders and regional law enforcement, is addressing concerns with crimes occurring at vape shops in the area.

On Friday, September 26, 2025, detectives within the Henrico County Police Division executed 10 search warrants on multiple vape stores suspected of selling marijuana and other illegal substances across Metro Richmond. Henrico Police worked with regional and federal law enforcement partners to conduct these searches at the following locations:

- The Simpson Smoke Shop – 7037 Staples Mill Rd (Henrico County)
- ZAZA Puff Palace – 3078 Hull Street Rd (Richmond City)
- ZAZA Wonderland – 3927 Hull Street Rd (Richmond City)
- ZAZA R US – 1838 E. Nine Mile Rd (Henrico County)
- Gas City – 1806 Fairmount Ave (Richmond City)
- Four residences in Henrico and Chesterfield counties
- One storage unit on Springfield Rd in Henrico County

Evidence collected from these searches resulted in more than 60 pounds of marijuana flower (worth over \$150,000), more than 12 pounds of THC edibles, approximately \$100,000 in cash, multiple firearms and vehicles.

“This crime trend is not unique to Henrico County, but rather a nationwide issue,” said **Henrico County Chief of Police, Eric D. English**. “Our sworn personnel across many units are heavily involved in finding ways to not only prevent these crimes from happening but enforcing the law and charging those responsible.”

Charges include transporting more than five pounds of marijuana into the Commonwealth, possession with intent to distribute marijuana, and possession of a controlled substance. One individual remains at large, and further indictments are pending.

In collaboration with the Henrico County Commonwealth's Attorney's Office, the Police Division works to educate the community about changes in the law on this topic. While recreational use of marijuana is now legal in Virginia, the sale for recreational use is still illegal.

Illicit products are becoming ever more prevalent in the Commonwealth at these vape shops. The Division's Drug Enforcement Unit investigates complaints of this nature while working in partnership with the Drug Enforcement Authority.

"One of our biggest concerns is our youth coming into possession of this product," English said. "We do have cases, dating back to 2024, where minors have broken into a vape shop, stole illicit product, and then sold it to their peers."

Currently, Henrico County has an ordinance ([Section 24-4323-F](#)) that prohibits the establishment of a vape shop within 1,000 feet of a school, or 2,000 feet of a public park or existing vape shop.

Henrico Police Investigates After Weapons Scanner Detects Firearm at School

(Henrico County, Va.) – Henrico Police is investigating after a weapons scanner and staff member at Fairfield Middle School successfully detected a firearm in a student’s backpack before entering the school.

Henrico County Public Schools (HCPS) began implementing weapons scanners at schools at the start of the 2023-24 school year. Since then, this is the first firearm detected by the equipment.

On Wednesday, October 1, 2025, around 8:15 a.m., the Henrico County Dept. of Emergency Communications received a 911 call from administrators at Fairfield Middle School (5100 block of Nine Mile Road) stating a firearm was located in a student’s backpack. The preliminary investigation indicates the student, age 12, walked through the weapons scanner and the equipment detected a possible weapon.

Officers responded to the scene and are working with HCPS to investigate the situation. Officers determined the firearm was loaded and petitions of possessing a weapon on school property (18.2-301.8) and possession of a weapon by a juvenile (18.2-308.7) were obtained against the student. The student was transported and admitted to the Henrico County Juvenile Detention Home.

“Henrico Police is committed to ensuring all students, staff and administrators remain safe while on school property,” said **Eric D. English, Henrico County Chief of Police**. “The addition of these weapons detectors by Henrico County Public Schools proved successful today and we thank school administrators for immediately reporting this situation.”

Henrico Police Investigates Fatal Two-Vehicle Crash Involving a Motorcycle

(Henrico County, Va.) – Henrico Police is investigating a fatal two-vehicle crash involving a motorcycle that occurred along the 4400 block of Carolina Avenue in Henrico's Fairfield District.

On October 1, 2025, at approximately 6:35 a.m., Henrico Police responded to the 4600 block of Carolina Avenue for a two-vehicle crash involving a motorcycle. Once on scene, officers located an adult male lying down in the southbound lane of Carolina Avenue. He was identified as the driver of the motorcycle and was pronounced deceased at the scene. Nearby officers also located a Hyundai Vera Cruz in the tree line off the southbound side of the roadway. The driver of the Hyundai, an adult female, was found on scene and transported to an area hospital for treatment of non-life threatening injuries.

Henrico Police Crash Investigators have identified the victim as **Bruce Scott Meade, 53, of Henrico.**

The preliminary investigation indicates Mr. Meade was riding his Harley Davidson motorcycle southbound on Carolina Avenue when the driver of a Hyundai Vera Cruz, traveling northbound, crossed into the southbound lane. Mr. Meade collided with the Hyundai, throwing him from the motorcycle. The Hyundai ran off the left side of the roadway, hitting several trees before coming to a stop.

As a result of the investigation, **Garnique Asianett Rodriguez, 21, of Henrico**, (the driver of the Hyundai) has been charged with the following.

Rabies Clinic Scheduled for October

(Henrico County, Va.) – The Henrico County Police Division will hold its final [rabies vaccination clinic](#) of 2025 for dogs and cats from **9 a.m. to noon on Saturday, October 18** at the **Henrico County Western Government Complex (4301 E. Parham Road)**.

Pet owners must register and pay at the cashier's office in the Administration Building before seeing a veterinarian on the first level of the adjacent parking deck.

Each vaccine costs \$20 and must be paid in cash. A rabies tag and a certificate of inoculation are included. Pets from all localities are welcome. Cats must be in carriers.

Under Virginia law, dogs and cats four months of age and older must be vaccinated for rabies.

Henrico dog licenses will also be available for \$10. Licenses are valid for the life of the animal while the owner lives in Henrico and its rabies vaccinations are kept current.

The Henrico Police Animal Protection Unit would also like to announce changes to these clinics come 2026. Moving forward there will only be two rabies clinics annually. The dates for the 2026 clinics are:

Firearm Detected by Weapons Scanner at Highland Springs H.S.

(Henrico County, Va.) – Henrico Police has charged an adult woman in connection with possessing a firearm on school grounds.

On Wednesday, Oct. 8, 2025, around 9:50 a.m., Henrico Police School Resource Officers (SROs) assigned to Highland Springs High School were notified about a possible firearm detected by the weapons scanner.

The preliminary investigation indicates an adult woman was attending an event at the school when she walked through the weapons scanner and it detected a firearm. School staff and the SROs immediately searched the bag and located the firearm, which was loaded.

Apryl Lynn Washington, 40, of Henrico, was cooperative with officers and faces charges of carrying a concealed weapon (18.2-308) and possession of a weapon on school property (18.2-308.1).

“These weapons scanners proved successful once again in detecting a firearm on a person, prior to them entering a school,” said **Henrico Chief of Police Eric. D. English**. “We are thankful for the quick actions of our SROs and school administrators for addressing this concern as expeditiously as possible.”

This appears to be an isolated incident and there is no threat to the students or staff. This is the second firearm detected by a weapons scanner since the equipment was implemented in schools during the 2023-24 school year.

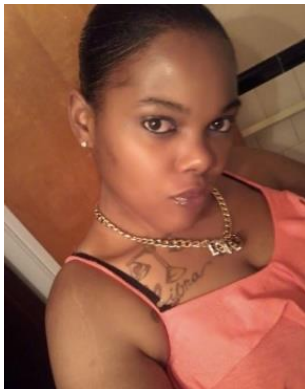
Henrico Police Searching for Missing Adult

Once on scene, officers located an adult male in the northbound lanes of the roadway with obvious signs of trauma. He was transported to an area hospital with life-threatening injuries where he remains hospitalized.

The preliminary investigation indicates the man was in the roadway when he was run over by a vehicle in the middle lane. The driver of the vehicle involved in the crash drove away from the scene. Investigators with the Henrico Police Crash Team are working to determine a cause and person/vehicle of interest related to this crash.

Henrico Police Locates Vehicle of Interest in Hit-and-Run Pedestrian Crash

Update 1:

(Henrico County, Va.) – Henrico Police has located a vehicle of interest involved in a now fatal-pedestrian hit-and-run crash from November.

On Sunday, Nov. 23, 2025, around 7:45 p.m., Henrico Police responded to the area of Brook Road and Bridgeport Avenue for a reported medical emergency. Once on scene, officers located an adult male in the northbound lanes of the roadway with obvious signs of trauma. He was transported to an area hospital with life-threatening injuries where he later died on Thursday, Nov. 27.

Henrico Police Crash Investigators have identified the victim as **Austin Chance Ratliff, 36, of Dry Fork, Va.,** which is just outside of Danville.

The preliminary investigation indicates Mr. Ratliff was struck within the northbound travel lanes of Brook Road as he was attempting to cross the roadway. The driver of the vehicle involved in the crash drove away from the scene. Information gathered from the public led investigators to identify a vehicle of interest which was located and taken into evidence. Henrico Police Crash Team Investigators continue to look into the circumstances and cause of this crash.

On Saturday, Dec. 6, 2025, around 1:35 a.m., Henrico Police responded to the 2100 block of Dickens Road for a reported shooting. Once on scene, officers entered a room in the building where two women, an adult and a juvenile (17), were located with apparent gunshot wounds. The adult was transported to an area hospital with serious but non-life-threatening injuries; the teenage girl was pronounced deceased at the scene.

Detectives within the Police Division's Criminal Investigations Section are in the early stages of this homicide investigation. The preliminary investigation indicates there was a large gathering at this location involving a number of juveniles.

"While homicides in Henrico County are down significantly this year, one death is still too many, especially that of a minor," said **Henrico Chief of Police Eric D. English**. "The Henrico County Police Division remains committed to reducing violent crime in the county."

This incident marks Henrico County's third homicide of 2025.

Henrico Police Makes Arrests in Dickens Road Homicide

UPDATE 1:

(Henrico County, Va.) – Henrico Police has made two arrests in connection to the deadly shooting at a motel off Dickens Road.

During the course of the investigation, detectives within the Criminal Investigations Section were able to identify **Kyre Omari Martin, 18, of Henrico**, and **Khalid Rashad Price, 18, of Henrico**, as suspects in the case. Mr. Martin and Mr. Price both face charges of second-degree murder.

On Saturday, Dec. 6, 2025, around 1:35 a.m., Henrico Police responded to the 2100 block of Dickens Road for a reported shooting. Once on scene, officers entered a room in the building where two women, an adult and a juvenile (17), were located with apparent gunshot wounds. The adult was transported to an area hospital with serious but non-life-threatening injuries; the teenage girl was pronounced deceased at the scene.

Detectives continue to investigate the circumstances of what led up to the shooting.

Update 1:

(Henrico County, Va.) – Henrico Police has charged the bus driver that was involved in a fatal crash on October 22, 2025.

The driver of the bus has been identified as **Hope Chamel Macklin, 48, of Richmond**, and she has been charged with the following:

- 46.2-816.1 - Careless driving and infliction of injury or death on a vulnerable road user.
- 46.2-839 - Any driver of any motor vehicle overtaking a bicycle proceeding in the same direction shall pass at a reasonable speed at least three feet to the left of the overtaken bicycle.

On Tuesday, December 30, 2025, around 5:55 p.m., Henrico Police responded to the intersection of Glenside Drive and Inglewood Street for the report of a pedestrian crash. Once on scene, officers located an adult female with obvious signs of trauma. She was pronounced deceased at the scene.

Crash Team Investigators have identified the deceased as **Barbara Ann Jones, 62, of Henrico.**

The preliminary investigation indicates Mrs. Jones, and another adult male, were crossing the northbound lanes of Glenside Drive when a Hyundai Santa Fe attempted to brake for the pedestrians and swerved to avoid them but collided with Mrs. Jones.
