### Two Wanted Individuals Taken into Custody in Henrico Toddler's Death

**(Henrico County, Va.)** – The two adults wanted on charges in connection to a June 2025 homicide have been arrested.

**Harvey Joe Turner, III, 42, of Henrico**, was taken into custody on Saturday, Jan. 17. **Jomaya Ciara Hunt, 19, of Henrico**, turned herself into authorities on Thursday, Jan. 15.

### **Original Release (01.15.25)**

**(Henrico County, Va.)** – Henrico Police has arrested one woman and is searching for two other adults following criminal indictments in connection to the death of a toddler in June 2025.

On June 3, 2025, around 11:15 p.m., Henrico Police responded to the 5400 block of Williamsburg Road for a reported medical emergency. Once on scene, officers located a female toddler (3) who was unconscious and not breathing. Officers immediately started life-saving measures until personnel with the Henrico County Division of Fire arrived on scene. The three-year-old girl was pronounced deceased at the scene.

Detectives within the Criminal Investigations Section have worked with several agencies over the last six months to investigate this case, including Child Protective Services, the Henrico

County Commonwealth's Attorney's Office and the Office of the Chief Medical Examiner (OCME). In September 2025, the OCME ruled the toddler's death a homicide due to drug toxicity.

On Jan. 12, 2026, a Henrico County Grand Jury issued criminal indictments for:

- **Tomeka Nichole Burton, 41, of Henrico**
- **Harvey Joe Turner, III, 42, of Henrico**
- **Jomaya Ciara Hunt, 19, of Henrico**

Ms. Burton was arrested following the grand jury hearing. She and Mr. Turner each face indictments of felony murder, child abuse (x2), child endangerment (x2) and possession of a schedule I or II drug. Ms. Hunt faces indictments of child abuse (x2). Mr. Turner (see picture) and Ms. Hunt are currently wanted. Anyone with information about their whereabouts is asked to call (804) 501-5000.
