IN ORDER TO help maintain healthy, attractive neighborhoods, the Henrico County Departments of Public Utilities and Community Revitalization organize a series of one-day Community Cleanups. This program is designed to assist residents in the disposal of large or bulky items, such as yard debris and unwanted furniture or appliances.

Please help us continue to provide this service at no cost by adhering to the program requirements:

- ❖ **This service is intended only for Henrico residents who reside in the cleanup area.**
- ❖ **Service will not accommodate contractors, developers, property owners conducting evictions or items from other neighborhoods.**
- ❖ **Only qualifying items placed at curb will be removed.**
- ❖ **The Community Cleanup supervisor reserves the right to not collect unacceptable materials or items considered dangerous to crew members or collection vehicles.**
- ❖ **Items not meeting program criteria, or are placed after 7 A.M. on the cleanup day will be left at the road's edge and the homeowner or resident will be responsible for its removal.**

If you miss your cleanup date, the Department of Public Utilities' offers a Bulky Waste Pickup service. This program has a \$67 fee for a pile size of 8' x 4' x 4'. ACCEPTABLE ITEMS



- Tree limbs must be no more than 4 feet in length and no more than 4 inches in diameter
 - Tree limbs must be separated from other items
- ✓ **LARGE APPLIANCES, SUCH AS OVENS, DISHWASHERS, WASHERS AND DRYERS**
- Doors must be removed or secured to prevent anyone from getting trapped inside
- ✓ **ELECTRONICS, SUCH AS COMPUTER MONITORS OR TVS**
- ✓ **FURNITURE AND MATTRESSES**
- ✓ **GRILLS, EXCLUDING PROPANE TANKS**

Pile size can't exceed what would fit into a standard pick-up truck bed (i.e., 8' x 4' x 4')

Items may not be placed more than 3 days before the cleanup date.

UNACCEPTABLE ITEMS

- ✗ **LARGER BRANCHES, TREE STUMPS, ROOT BALLS**
- ✗ **YARD DEBRIS (E.G., LEAVES, PINE TAGS, SMALL TWIGS, ETC.,)**
- ✗ **LOGS**
- ✗ **HOUSEHOLD GARBAGE**
- ✗ **HAZARDOUS OR LIQUID WASTE**
- ✗ **PAINT**
- ✗ **PROPANE, OIL OR GASOLINE**
- ✗ **PESTICIDES**
- ✗ **VEHICLE BATTERIES OR PARTS**
- ✗ **CONSTRUCTION OR DEMOLITION DEBRIS**
- ✗ **LAWNMOWERS**
- ✗ **GLASS, MIRRORS OR WINDOWS**
- ✗ **REFRIGERATORS OR HVAC EQUIPMENT**
- ✗ **TIRES**
- ✗ **ITEMS NOT PLACED AT THE ROAD'S EDGE BY 7 AM ON CLEANUP DAY**
