Department of Community Revitalization December 27, 2012

On December 27, 2012, the County of Henrico amended the 2012-13 Annual Consolidated Community Development Action Plan.

Notice of this proposed change was published in *Style Weekly* on November 28, 2012. A copy of that notice is provided below.

Public Notice Henrico County, Virginia Amendment to the 2012 Consolidated Plan

On or about December 27, 2012 Henrico County, Virginia will submit to the U.S. Department of Housing and Urban Development an amendment to the Henrico County Consolidated Plan reprogramming 2009 CDBG funds of \$21,278 from South Elm Road Drainage Improvements and \$2,638 from Sandston Ballfield Parking Lot; 2010 CDBG funds of \$509 from MH&DS Group Home Improvements and \$6,000 from HOME Inc. Downpayment Assistance; 2010 HOME funds of \$23,250 from HOME Inc. Downpayment Assistance; 2011 CDBG funds of \$7,442 from CDBG MH&DS Group Home Improvements, \$1,500 from HOME Inc. Downpayment Assistance, \$37,500 from RAMPS, and \$10,000 from Lakeside Avenue Gateway Improvements; and 2011 HOME funds of \$3,915 from HOME Inc. Downpayment Assistance; all totaling \$114,032. Reprogrammed funds will be allocated to 2012-13 existing projects in the following amounts: \$51,000 of CDBG funds and \$27,165 of HOME funds to ElderHomes T/A project:Homes Homeowner Rehabilitation, \$35,867 of CDBG funds to Enterprise Zone Façade Grants; all totaling \$114,032.
