#### **Preface**

The County of Henrico, for Program Year 2023-24, was a recipient of federal Community Block Grant (CDBG) and HOME Investment Partnerships (HOME) annual entitlement funds through the U.S. Department of Housing and Urban Development (HUD). A requirement of receiving these funds is to submit to HUD, within 90 days of the end of the program year, a report assessing progress in meeting the goals and objectives established in the Consolidated Plan and specific accomplishments and expenditures during the program year. The Henrico County program year is from October 1 to September 30.

The official submission of the Consolidated Annual Performance and Evaluation Report (CAPER) is provided to HUD through the online eCon Planning Suite in HUD's Integrated Disbursement and Information System (IDIS). Henrico County's CAPER submission will occur by December 30, 2024.

This document provides a printed version of information submitted to HUD through IDIS. This document is not the official submission, but rather a compilation of the online information submitted, using a data exporting function provided by IDIS. Once exported, that information was reformatted to provide a more user-friendly document and to make available key informational reports used by HUD in evaluating local government programs for the year. These reports are provided as attachments to this document. For Program Year 2023-24, Henrico County did not receive an allocation of ESG funds, although a small number of programs utilized remaining ESG funds from the prior year. Hence, this CAPER provides only limited data on ESG accomplishments and does not include the annual SAGE report. This reporting is expected to resume for 2024-25 when ESG funding was restored.

Major accomplishments of Henrico County, Virginia, for PY 2023-24 include the following:

- Affordable housing was provided to 101 households through moderate home rehabilitation (21), minor home repairs (57), and down payment assistance (23).
- Homelessness prevention, case management, and shelter were provided to 183 persons through programs supported by CDBG funds and 2022-23 ESG funds.
- Public services were provided to 134 persons through the CONNECT Program.
- Economic development efforts assisted 5 businesses.
- An apartment building, providing permanent supportive housing for 86 very low-income persons, was completed.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

The preservation and development of affordable housing, community economic development, mitigation and prevention of homelessness, and non-housing community development are the four high priority needs identified in the 2020 Consolidated Plan. These priorities were addressed in 2023-24 through the following programs:

Note: HOME expenditures represent amounts drawn during the PY23-24 and therefore may differ from the actual expenditures associated with the specific activities completed during the year.

- Homeowner Rehabilitation through project: HOMES. 15 homes completed (\$185,089.50 CDBG and \$731,240.40 HOME).
- Critical repairs to homes owned by LMI homeowners through project: HOMES and Richmond Habitat. A total of 57 repairs were completed (\$638,394.53 CDBG, including prior year funds).

- Down payment & closing cost assistance through SCDHC to enable homeownership for low-income first-time homebuyers. Funding provided assistance to 10 homebuyers (\$189,845.72 HOME and \$19,410 of prior-year CDBG).
- Down payment & closing cost assistance through HOME Inc. to enable homeownership for low-income first-time homebuyers. Funding provided assistance to 13 homebuyers (\$182,219.00 in HOME and \$21,000 of prior-year CDBG).
- After-school substance abuse prevention and life skills through the CONNECT Program for at-risk youth residing in 11 low-income communities. 134 students were served throughout the program year (\$184,000 CDBG).
- A program assisting homeless families in Henrico Schools McKinney-Vento program provided funds to assist with costs associated with use of the CARITAS furniture bank. 49 persons were assisted (14 households) (\$2,000 CDBG).
- Henrico County did not receive an allocation of ESG funds for 2023-24. 2022-23 ESG funds as well as ESG-CV remained available and \$3,289.91 (combined funds) was expended for programs that served 2 households with rapid re-housing, and \$84,684.99 (combined funds) was expended for shelter programs through Housing Families First that served 145 persons. \$5,000 of ESG funds were drawn for expenses for the prior year shelter case management program operated by CARITAS, and \$2,423.70 was drawn for expenses for the prior year for the street outreach program operated by Commonwealth Catholic Charities (CCC).
- \$50,000 of CDBG was allocated to assist with the development of permanent supportive housing for very low-income persons. This amount supplemented prior program year allocations and expenditures. The \$50,000 was drawn in PY 2023-24 and the project completed, providing housing for 86 persons.
   \$300,000 in HOME funds was allocated to assist with the development of rental housing for low-income families through the development of Carter Woods III. Construction has not yet begun on the project, and no funds were expended.
- The Commercial Assistance Program, which provides technical assistance and support to small businesses in Henrico's Enterprise HIP Zone, continued in PY 2023-24 and resulted in the creation of 5 new jobs for LMI individuals at a cost of \$162,213.91.

In addition to regular entitlement funds, Henrico continued to expend CDBG-CV funds which reported the following accomplishments in 2023-24: OAR of Richmond (5 persons), CCC Dibert Food Pantry (5,782 persons), CCC Housing Assessment & Transition Support (11 households), and HumanKind Family Crisis Fund (34 persons). Additionally, a program of homeless outreach, previously funded with ESG, was awarded CDBG-CV funds of \$30,000 in order to continue that program, serving 12 persons in PY23-24.

During PY23-24, remaining 22-23 ESG funds were allocated to programs and supplemented with ESG-CV funds. Both the ESG-CV and the 2022-23 ESG program were closed out during PY 2023-24. Specific accomplishments are provided in Table 1 and includes both ESG and ESG-CV.

#### **Narrative**

The numbers in the CDBG column in Table 2 above reflect all CDBG programs in PY 2023-24, including administration of the project:HOMES Moderate Rehabilitation Program. This includes a total of 287 persons assisted including persons in the categories of Other Multiracial (8 persons) and Black or African American & White (36 persons) which differ from the above listed numbers due to the exclusion of these two categories in IDIS.

Additionally, the following persons were served during the program year through programs funded with PY 2019 CDBG-CV funds:

- 12 persons through the homeless outreach program through Commonwealth Catholic Charities (2 White; 10 African American)
- 411 persons through the Commonwealth Catholic Charities Dibert Food Pantry (174 White; 15 White Hispanic; 175 Black or African American; 7 Black and White; 40 Other Multi-Racial)
- 34 households through the HumanKind Family Crisis Fund (24 African American; 4 white; 1 White Hispanic; 1 Asian; 4 Other Multi-Racial)
- 5 persons served through OAR in PY 2023-24 (1 Asian; 2 African American; 1 American Indian-Alaskan Native; 1 other (Hispanic)).
- The Commonwealth Catholic Charities Housing assessment and Transition and Support Program assisted 47 households containing 178 persons through placements in permanent housing.

The numbers in the HOME column in Table 2 above reflect the total number of households served during PY 2023-24 through the following projects: project: HOMES Homeowner Rehabilitation, SCDHC Downpayment Assistance, and HOME Inc Downpayment Assistance. 15 homeowner rehabilitation projects were completed in PY 2023-24. However, funds drawn can reflect funding from prior year projects paid early in the program year and may not reflect payments for projects completed late in the program year that were not drawn until early in PY 2024-25.

The demographic numbers in Table 2 may include some combination of both household and individual numbers, as different programs require different data-counting practices.

The numbers in the ESG column in Table 2 above reflect only demographic data related to the following projects: Housing Families First Hilliard House Shelter and Housing Families First Rapid-Re-housing.

In PY 2023-24, the majority of families/individuals assisted were non-white minorities. For CDBG, 89% of those assisted (non-housing and housing activities) were racial and ethnic minorities. For HOME, 89% of those assisted were racial and ethnic minorities. For ESG, 92% of those assisted were racial and ethnic minorities. Overall, the County's population is 49.1% racial and ethnic minorities.

#### Narrative

Table 3- "Resources Made Available" reflects PY 2023-24 allocations plus prior year funds brought forward and includes any amendments to the Annual Action Plan made during the Program Year.

"Amount Expended" for **CDBG** reflects draws that were all associated with expenditures that occurred during PY 2023-24 plus any draws that occurred in the first month of PY 2024-25 that were associated with the 2023 Program Year. This total does not include draws that occurred at the beginning of PY 2023-24 and were associated with expenses from the prior (2022-23) program year. Sources and expended totals do not include CDBG-CV funds.

"Amount Expended" for **HOME** reflects draws that occurred during PY 2023-24. These funds were primarily drawn for activities associated with the 2023-24 grant or earlier grants. Not reflected in the "Expended" amount in Table 3 includes 2023 grant funds expended (drawn) in the first few months of PY 2024-25 which may have been associated with 2023 activities. The amount drawn is based on the LOCCS Send Date as reported on the PR-07 and/or the date of voucher submission. HOME Funds do not include HOME-ARP funds.

"Amount Expended" for **ESG** reflects draws that occurred during the program year. All of the amount drawn (\$73,388.26) was Grant Year 2022 funds drawn during the 2023 program year. Information for amounts expended was derived from PR-07 reports, *Drawdown Report by Voucher Number – Vouchers Submitted to LOCCS*. and/or the date of voucher submission.

\$34,072.71 of HOME Program Income (includes PI and HP funds) was received and a total of \$40,288.41 was expended (drawn) during the program year. No additional CDBG-CV funds were made available during the program year. During 2023-24, CDBG-CV expended (drawn) amounts totaled \$201,426.59.

#### Leveraging

Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.

The use of federal CDBG and HOME funds by Henrico County leveraged over \$3 million in state, local, federal, and private funds. This leveraged amount includes the following: County contributions from the general fund budget to 26 agencies providing services, towards the development of a supportive housing project, and to a local land trust for affordable housing; HOME match as reported in this CAPER; CDBG leveraged amounts reported as "other funds" in IDIS; value of financial and material contributions for HOME-eligible projects through sub-recipient volunteer programs; and value of volunteer time for assistance with improvements to HOME-eligible households.

Many of Henrico's CDBG, HOME, and ESG subrecipients oversee regionally supported projects and receive funds from multiple jurisdictions, as well as additional state funding. In addition, several agencies operate their programs in publicly owned facilities or on publicly owned land. Henrico County owns the land and building used by Housing Families First as a homeless shelter and administrative offices for a rapid rehousing program. In addition to the funds leveraged by the Connect program, inkind contributions of program space from four apartment communities are provided. The Cool Lane Commons Apartments supportive housing development with 83 units, completed in 2023-24 is in a building originally donated by the City of Richmond, which had been a dilapidated former city nursing home.

During the 2023-2024 school year HCPS identified 1,151 students as eligible under McKinney-Vento. During FY 2023-2024, Henrico County Public Schools (HCPS) was in year one of a three-year grant. The grant was awarded by Project Hope of Virginia as part of the McKinney-Vento Homeless Education Act. The total award amount for the 2023-2024 fiscal year was \$140,000. Funding covered program staff, engagement and enrollment events, staff professional development and out-of-zone transportation support to get students to/from school.

As of December 5, 2024, as reported by the HUD Community Assessment Reporting Tool (CART) (<a href="https://egis.hud.gov/cart/">https://egis.hud.gov/cart/</a>), there are 2,254 housing units in Henrico County receiving project-based rental assistance. There are an additional 1,845 housing choice (tenant-based) vouchers used in the County. These vouchers are issued and managed by several different agencies, with the majority issued and managed by the Richmond Redevelopment and Housing Authority. Vouchers are also issued and managed by Richmond Residential Services for adults with intellectual disabilities through the HUD Veterans Affairs Supportive Housing (HUD-VASH) program, Henrico Area Mental Health & Developmental Services (HAMHDS) and the Central Virginia Resource Corporation (CVRC).

HOME matching requirements were provided through a variety of sources including volunteer program contributions, cash provided by homebuyers, and other matching grants. ESG matching requirements were provided in PY 2022-23, as there were no ESG entitlement funds provided in 2023-24.

# Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

Table 11 — The "one-year goal" number represents households served through the Commonwealth Catholic Charities Homeless Diversion and Stabilization Program serving McKinney-Vento families, with 10 households served.

Table 12 — The 'Actual' number of 3 households provided relocation or rental assistance (OAR -CDBG funds); the 'Actual' number of 72 households is homeowner rehabs and repairs through project:HOMES and Richmond Habitat. The actual number of 23 represents down payment assistance grants for first-time homebuyers (acquisition of existing units), providing a grand total of 98 households assisted.

Significant differences between the one-year goals and actual production in tables 11 and 12 are attributed to the following:

• Table 12, Row 1: The One-Year goal was a projection for households served through OAR, with an actual of 3. Decline was due to a reduced demand from pandemic-affected clients. Row 2: The One-Year goal for production of new housing units included 2 CHDO projects and 53 units of rental housing in a large multi-family project. The 53 units are expected to be completed in 2026, the timeline of which is typical for this type of project. Two CHDO houses were completed, however are not reflected in this CAPER as the projects have not been marked as "complete" in IDIS, something that will occur in early PY 2024-25. Row 4 includes DPA projects completed by HOME Inc. and SCCHC. During the program year, both programs were provided access to unspent prior year funding as that was not anticipated when the annual goal was established.

#### Discuss how these outcomes will impact future annual action plans.

Given the success with the homeowner repair and rehabilitation programs, little change is expected. If additional funds are provided in future HUD allocations, corresponding increases in allocations to the repair and rehabilitation programs will likely be provided, given the improvement in program performance by subrecipients. During PY 2023-24, the Downpayment and Closing Cost Assistance program was successful in achieving all production goals following program adjustments. Because of this success, future action plans will likely continue to provide funding to enable low- and moderate-income households to become homeowners. Performance of all programs is closely monitored so that mid-year program adjustments and reallocations can be made. Allocations may be reduced in future Action Plans for subrecipients who are unable to fully meet their expectations and spend the funds

allocated. Subrecipients who demonstrate they are able meet their goals and spend all funds are considered for additional funding in future years or supplemental funding in current year if available.

#### **Narrative Information**

The CDBG numbers in Table 13 above include the households or individuals served under the project:HOMES repair program (51) and the Richmond Metro Habitat for Humanity roof repair program (6). The total also includes double-counting of households served in the HOME-funded homeowner rehabilitation program due to the use of CDBG funds for administrative costs and portions of rehabilitation costs. HOME numbers include households served by the project:HOMES moderate rehabilitation program and the HOME Inc. and Southside Community Development and Housing Corporation down payment assistance programs.

# CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c)

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

During the 2023-24 program year, Henrico County funded non-profit agencies through the non-departmental component of the General Fund budget to prevent homelessness, and to provide case management, food and shelter for single-adults and families experiencing homelessness. In addition, supportive services were provided for at risk of homelessness individuals and families, to keep them in permanent housing.

ESG entitlement funding was not provided in PY 2023-24, but was reinstated in PY 2024-25. Remaining CDBG-CV funds were able to provide the following in PY 2023-24:

Commonwealth Catholic Charities provided street outreach to 12 individuals in Henrico County.

#### Addressing the emergency shelter and transitional housing needs of homeless persons

During PY 2023-24, Henrico County did not receive an allocation of ESG entitlement funds. However, the following were served with either prior year ESG funds or 2023-24 CDBG funds.

- Housing Families First provided emergency shelter to 145 individuals and 46 families, of which 31 individuals and 11 households identified as being from Henrico County.
- Housing Families First provided rapid rehousing to two households.
- Through Commonwealth Catholic Charities relocation of McKinney-Vento families living in hotels to permanent housing was provided to 14 households (49 persons).
- 21 households living in hotels were relocated to permanent housing through the Hotel to Housing Transition Support program.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Henrico County's Department of Social Services (HDSS) created the Family Services Intake Unit in 2010 to assist families and individuals in crisis. The intake unit manages the local hotlines for Child protective Services, Adult Protective Services, and the Community Resource Line. The intake unit responds to emergency needs requests via the Community Resource line by providing information and referrals and homeless prevention assessments. Citizens contact the intake unit for a wide variety of emergency needs that can include housing, utilities, food, clothing, and medical.

In the period from July 1, 2023 to June 30, 2024, the Family Services Intake Unit completed 1,690 Child Protective Services referrals, 1,524 Adult Protective Services referrals, and 595 requests for assistance, information, and referral.

CDBG and CDBG-CV funds were used to assist persons being released from incarceration in Henrico County. During PY 2023-24, 8 such persons were provided housing assistance – 5 with remaining CDBG-CV funds and 3 with PY 2023-24 funds. CDBG funds were also used for a prevention and diversion program that benefitted 33 persons (10 households).

A new CDBG-CV funded program of emergency assistance was initiated in PY 2023-24 to provide households with one-time emergency payments. Of the 34 persons served in PY 2023-24, 29 received housing assistance in the form of rent and/or utility assistance to prevent becoming homeless.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals

# and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Prior year ESG and ESG-CV funds assisted 46 families with shelter as step to transition to permanent housing. CDBG funds provided homelessness prevention for 10 McKinney-Vento families through relocating them from hotels to permanent housing. 21 households were served through a similar program using CDBG-CV and County general funds.

CDBG funds were used to assist homeless Henrico County Public Schools families moving into permanent housing by paying fees associated with use of the CARITAS furniture bank to furnish the new home.

#### CR-30 - Public Housing 91.220(h); 91.320(j)

#### Actions taken to address the needs of public housing

The County of Henrico has no public housing. Henrico County encourages affordable homeownership for low-income households through several programs. Specific actions during PY 2023-24 to remove barriers and promote affordable housing included the following:

- Allocation of \$100,000 to HOME Inc. for down payment/closing cost assistance and homeownership counseling as well as \$69,632.50 of prior year HOME funds.
- Allocation of \$71,000 to Southside Community Development and Housing Corporation for down payment/closing cost assistance and homeownership counseling, as well as \$62,500 of prior year HOME funds.
- Allocation of \$579,427 to project:HOMES for Critical Home Repairs.
- Allocation of \$50,000 to Richmond Metropolitan Habitat for Humanity as well as \$25,000 of prior year funds for Critical Home Repairs.
- Allocation of \$817,904 to project: HOMES for Homeowner Rehabilitation Program.
- Allocation of \$153,700 for CHDO activities to create new affordable housing.
- Allocation of \$112,000 for affordable housing support to fund infrastructure or utility work in support of affordable housing.
- Allocation of \$300,000 of HOME funds to Carter Woods III for assistance in development of affordable housing for low-income seniors. This includes \$50,000 of reallocated CDBG funds allocated in the prior program year.
- Allocation of \$50,000 to Cool Lane Commons supportive housing apartments. This was addition to CDBG and general fund allocations in previous years.
- Henrico County routinely supports applications for Low Income Housing Tax Credits, including those that receive an allocation of project-based vouchers.

# Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The County of Henrico has no public housing.

#### Actions taken to provide assistance to troubled PHAs

The County of Henrico has no public housing.

#### CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

Henrico County works in numerous ways to reduce the barriers to affordable housing. Building codes and tax policies are governed by state law and not subject to local adjustment but the County continues to provide an exemption from real estate taxes for low/moderate-income seniors and disabled homeowners through the Real Estate Advantage Program (REAP), beginning in PY 2023-24, the RECAP Program. Henrico reduces barriers to residential development of all types by not requiring cash proffers. The real estate tax rate in Henrico County is among the lowest in the region and is the lowest among large urban localities in Virginia. The Comprehensive Plan designates substantial area for residential development and Henrico County regularly approves new subdivisions and multi-family development for all income levels. During County Fiscal Year 2023-24, permits were issued for 837 new single-family homes, a 20% increase from the previous year. 118 permits were issued for two-family buildings, a 22% decrease from the previous year. 21 permits were issued for multi-family buildings, an 11% increase from the previous year.

A substantial overhaul of the County Zoning Ordinance occurred in September 2021, with further amendments in December 2022, and September 2024, many of which removed barriers to affordable housing including removal of townhouse rental limitations, adding "live/work" residential use, allowing accessory dwelling units (ADUs), and greater ability to develop nonconforming residential lots, and adding language for compatibility with State law for accommodations for persons with disabilities.

The 2020 Analysis of Impediments to Fair Housing Choice in the Greater Richmond and Tri-Cities Region (AI), prepared by a consultant independent from Henrico County and completed in February 2021, identified no impediments to fair housing choice resulting from the negative effects of public policies. An analysis undertaken in PY 2019 as part of the development of the 2020 Consolidated Plan and the 2020-21 Action Plan evaluated the opportunities for affordable housing for Henrico home purchasers. That analysis determined that 42.8% of the single-family homes in the County were affordable by households earning up to 80% Area Median Income, if available for purchase. This is a decrease from 2015 when 62% fell into this category. This analysis was undertaken again for calendar year 2022 and the percentage of housing that fell into this category further decreased to 24.9%. The Richmond Regional Housing Framework, prepared by the Partnership for Housing Affordability in January 2020, identified housing needs and challenges in the Richmond Region as well as Henrico County specifically. The Framework provided five "goals" and six general "solutions" for Henrico.

As of December 5, 2024, the rental housing market includes 2,254 units supported by project-based housing choice vouchers or equivalent programs, providing housing opportunities for very low-income households. According to the Department of Housing and Urban Development's (HUD) Enterprise

Income Verification (EIV) data (<a href="https://egis.hud.gov/cart/#">https://egis.hud.gov/cart/#</a>), there are 1,845 portable housing choice vouchers in use in Henrico County. Additionally, 3,833 rental units are supported by low-income housing tax credits, and an additional 5,860 units are supported by tax-exempt bond financing, according to the Virginia Housing LIHTC Database.

#### Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

While there are several constraints to meeting the needs of low-, very low-, and moderate-income residents, the primary obstacle has been the lack of funding to fully address all needs. In response to the level of need, Henrico County continued in PY 2023-24 to allocate a significant portion of its CDBG entitlement for housing or housing related assistance, providing 85.2% of non-administrative funds for this purpose. Additionally, Henrico County created the Revitalization Fund in 2018, allocating \$2 million for the purpose of addressing vacant and blighted property for rehabilitation or new construction to provide homeownership opportunities for low- and moderate-income households. Since then, an additional \$5.8 million has been provided to the fund. Most recently, during PY 2023-24, \$800,000 these funds were committed to the Maggie Walker Community Land Trust to support the development of 12 single family homes, available to households earning less than 115% AMI.

Also during 2023-24, Henrico-owned land was conveyed to the Land Trust for a mixed housing development at Airport Drive and Washington St. that would also include housing for persons fleeing domestic violence and affordable housing for households less than 110% AMI.

During 2023-24, the Annual Action Plan was amended to incorporate unspent prior-year CDBG and HOME. All of the additional funds went to housing programs.

Henrico County also continues to support the allocation of Low-Income Housing Tax Credits to developments in Henrico. In PY 2023-24, one Henrico project received an allocation of competitive tax credits in the 2024 cycle for the new construction of 53 units of accessible housing. This project (Carter Woods III) also received Henrico HOME funds. Completion is expected in 2026.

Another significant issue that became more severe during PY 2023-24 has been the lack of available affordable housing for both purchase and rent. On the home purchase side, the percentage of single-family homes that are affordable to a household earning less than 80% AMI decreased dramatically. Despite having homebuyer assistance funds available, potential homebuyers were unable to find homes available. In response to this, Henrico County continued to calculate local housing values for use in lieu of the HUD value limits for the HOME Program and for 2023-24 substantially increased the amount of Downpayment funds available for individual low-income homebuyers.

During PY 2023-24, Henrico County established a Housing Trust Fund, effective July 1, 2024, funded by real estate taxes generated by data centers located in the County. The initial commitment to the Trust Fund was \$60 million over five years. Funds can be used to acquire land for housing, engineering and design, site preparation, and construction. Trust fund developments are also eligible for various county fee waivers.

#### Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

As referenced in the Annual Action Plan, Henrico County provides up to \$5,000 for lead-based paint assessment and abatement for homes receiving assistance through the moderate rehabilitation program.

All CDBG and HOME activities in Henrico County which involve the purchase or repair/renovation of houses built prior to 1978 follow federal lead-based paint regulations. During the implementation of these activities, appropriate steps are taken depending on the level of funding for the unit when lead-based paint is detected or presumed to be present. Subrecipient staff is trained on lead-based paint requirements (HUD Lead Safe Work Practice Certification; EPA Renovation, Repair and Painting Certification; and Healthy Homes for Community Health Worker Certification) and practices and each homeowner in a pre-1978 home is provided the EPA/HUD booklet Protect Your Family from Lead in Your Home. Homeowners in repair/rehabilitation programs also receive the EPA booklet "The Lead-Safe Certified Guide to Renovate Right." A homeowner's signature noting receipt of these documents is placed in each client file. Contractors used for repair/rehabilitation work are all EPA-certified under 40CFR Part 745.82 and 745.84.

#### Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

The Commercial Assistance Program, the Enterprise Zone Façade Grant program, and the Enterprise Zone Design Assistance program facilitate development and expansion of businesses to create jobs available to low- and moderate-income persons including persons in poverty.

Funding was provided in PY 2022-23 for a small business revolving loan fund. That program remained under design during the program year. Its intent is to assist small and minority owned businesses with the outcome of creating jobs for low- and moderate-income persons.

Poverty level data for Henrico County from the Census Bureau American Community Survey 1-Year Estimates. Following decrease in persons in poverty between 2020 and 2021, the number then increased in 2022 to 30,014 persons, and increased further to 31,225 persons in 2023. The 2023 numbers represent a poverty rate of 9.4%.

The Henrico County Economic Development Authority actively recruits businesses to locate in Henrico County, providing employment with living wages. During PY 2023-24, several businesses announced or completed expansions or new locations in Henrico County including KSB North America with 32 new jobs, Berkley Insurance Company with 72 new jobs, Tucker Door & Trim with 50 new jobs, an Amazon robotics fulfillment center, and expansion of Coca-Cola Consolidated Bottling Company's production and distribution facility.

#### Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The County has designated staff to administer the programs and activities funded with CDBG, HOME and ESG funds. Staff work with individual County Departments, including Public Works, Social Services, Recreation and Parks, Mental Health, Planning, Public Utilities, Building Inspections, and the Division of Community Maintenance to coordinate the administration of programs to be carried out. Staff regularly track the production and effectiveness of County agencies, and subrecipients tasked with implementing

programs with CDBG, HOME, and ESG funds. Program staff regularly meet to discuss program implementation, enhancements, and adjustments with these agencies. During the 2023-24 program year County staff continued to build and foster relationships with homeless service providers and the region's coordinating agency, as well as agencies able to administer small business assistance programs.

# Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

Actions taken included:

- Continued participation as an active partner in the Richmond Regional Continuum of Care, addressing homeless issues in the metropolitan area.
- Continued policy of no cash proffers for the development of new single-family houses to ensure greater affordability.
- Provided funds for down-payment and closing costs assistance to facilitate homeownership opportunities for low-income individuals.
- Regular communications and discussions with all currently funded housing providers and others.
- Convened a bi-monthly meeting of multiple County agencies (Resource Team) involved in addressing housing, social service, safety, and mental health needs of predominantly lowincome Henrico residents.
- Continued representation on the regional non-profit Partnership for Housing Affordability
- Participation in the bi-monthly meeting of the Richmond Community Development Alliance fostering coordination among Richmond area housing non-profits and the three entitlement jurisdictions.
- Representation on the Continuum of Care Board and the Ranking Committee
- Henrico County routinely enters into Memoranda of Agreement with new or about to be renovated apartment communities seeking tax credits or bond financing to ensure high quality improvements, public safety, and quality living environments.
- Creation of the Henrico Housing Trust Fund enabled the ability to provide financial support for private development of affordable housing.

# Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

In February 2021, Henrico County completed the 2020 Analysis of Impediments to Fair Housing Choice in the Greater Richmond and Tri-Cities Region (AI). This document was a regional undertaking involving the six entitlement jurisdictions in central Virginia (Henrico and Chesterfield Counties, and the Cities of Richmond, Petersburg, Colonial Heights, and Hopewell) The AI was prepared by a consultant and identified impediments specific to each individual jurisdiction as well as regional impediments.

There were three impediments specific to Henrico County:

1. Denial of housing to renters by landlords refusing to accept housing vouchers.

- 2. Denial for mortgage loans for African American/Black applicants and Latino/Hispanic applicants at 2 and 1.5 times the rate respectively of those for white applicants.
- 3. High opportunity environments not available to all residents:
  - 1. an imbalance of modest wage jobs and affordable housing units with 20,000 more jobs than housing units.
  - 2. the widest gap in the region in access to high-performing schools for non-white and Hispanic children.

Specific Action Items for Henrico County were provided as follows:

- 1. Participate in a Working Group to coordinate implementation of the Fair Housing Action Plan. PlanRVA originally intended to coordinate this effort potentially in conjunction HOME, Inc. and reached out to all Participating AI localities. Ultimately it was determined by a majority of the participating AI localities to assume their own responsibility for implementation of the Fair Housing Action Plan as assigned to each locality.
- 2. Commit to funding fair housing education and outreach. Henrico County has provided prior year funding for this activity.
- 3. *Increase the supply of multi-family rentals*. During Calendar Year 2023, Henrico County added 1,847 units of multi-family housing.
- 4. Strengthen funding for eviction programs. Funding was provided in PY20-21 and 21-22 for such a program. Those programs in 2021-22 served a total of 990 households through the use of CDBG and CDBG-CV funds. The agency providing this service to Henrico residents did not request further funding for PY22-23 or 23-24.
- 5. Support state and federal regulatory reform to address rental housing disparities. Key changes occurred to State law in 2022 that eliminated barriers based on source of rent (i.e., landlords could no longer refuse to rent to voucher holders).
- 6. Include recommendations from the AI into the County Comprehensive Plan update. The Plan update continued through 2023-24 and an initial draft of a housing analysis was completed. Recommendations are expected to be developed and adopted into the Plan during 2024-25.
- 7. Support the expansion of the regional land trust. Henrico County has provided funding in the amount of \$825,077 to the regional land trust in prior years to fund a 21-home subdivision and other single-family homes and an additional \$114,867 in PY 2023-24.
- 8. Continue to fund home repair and rehabilitation programs. For PY23-24, just under \$1.5 million of CDBG and HOME funding was provided for this purpose.
- 9. Support recommendations of the "Confronting School and Housing Segregation in the Richmond Region" study.
- 10. Prioritize funding to expand public transportation and support affordable housing near job-rich areas. In PY23-24 GRTC Service was further expanded, with bus transit now serving numerous areas of Henrico County including: Brook Road to Virgnia Center Commons, Staples Mill Road

and the Henrico Government Center; Laburnum Avenue, Nine Mile Road, and the Airport; Patterson Avenue to Regency Square.

#### CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

Monitoring of CDBG, HOME, and ESG subrecipients is the responsibility of the Dept. of Community Revitalization. The intent is to conduct a full program monitoring of all programs either annually or biannually.

In addition to any full program monitoring, ongoing monitoring of activities and programs always occurs, which consists of close scrutiny of all subrecipient invoices to ensure they are supported by adequate documentation explaining and justifying all expenses and client eligibility, and that all CDBG, HOME, and ESG requirements were met. County staff will frequently request additional supporting documentation to verify any of these items and will deny payment of invoices if adequate documentation cannot be provided. County staff will also undertake site visits and meet in-person or virtually with subrecipient staff to discuss program issues and reiterate program requirements as needed.

The annual or biannual monitoring of programs involves a review of a sample of program activities completed during the previous contract period and up through the time of the review. The files are evaluated to ensure compliance with HUD regulations, County requirements, other applicable standards as well as the approved project plans (for construction projects), compliance with environmental review requirements, and compliance with fair housing laws. Monitoring visits may be conducted any time of year and may be conducted at the subrecipient's offices or at County offices. For all programs where third-party services or products are purchased, particularly anything involving construction, invoices and billing records are reviewed to ensure that expenses incurred reflect the expenses charged to the project. For projects where staff time is charged, documents are reviewed to support charges. All charges for all programs are reviewed to ensure there has been no duplicate charging of expenses to other funders, with particular attention to any other CDBG, HOME, or ESG funding. Monitoring of CDBG-CV and ESG-CV programs includes a review to verify there has been no duplication of benefits and that all expenses meet the CARES Act requirement of nexus to COVID-19.

Monitoring results are provided in writing to subrecipients, first in draft form for review and comment. A final report is prepared within 30 days of receiving comment including any necessary findings or concerns along with any required or recommended corrective actions.

The required organization structure, capacity, and financial status of CHDO's is reviewed whenever certification is required for a project.

In general, checklists and review procedures are implemented in accordance with HUD's *Community Planning and Development Monitoring Handbook*, Feb. 2017.

All subrecipients are required to submit monthly or quarterly reports detailing the status of all activities throughout the program year. County staff review each report for financial and programmatic accuracy

and program progress. Site monitoring occurs regularly for construction projects while underway, and prior to construction and upon completion for all rehabilitation and repair projects. For all projects and programs, as compliance issues arise during the year, immediate corrective actions are required of subrecipients and CHDOs.

All subrecipients and users of Enterprise Zone grant funds are required to follow County procurement processes. These require solicitation of bids from WMBE firms for most purchases.

All projects are reviewed to ensure they conform to the County's Comprehensive Plan and the Consolidated Plan before funding is allocated.

During PY 2023-24 no separate formal monitoring was completed.

Notice of the availability of a draft Annual Performance Report was published in the Richmond Times-Dispatch on December 3, 2024. The draft report was published on the County's website. A hard copy was also available for review. Citizens were given 15 days to review and provide comments on the document.

#### CR-45 - CDBG 91.520(c)

Specify the nature of, and reasons for, any changes in the jurisdiction's program objectives and indications of how the jurisdiction would change its programs as a result of its experiences.

Henrico County evaluates all programs continuously throughout the program year and implements changes as needed. This can include reallocating unspent funds from prior years and allocating any program income received during the year. This typically results in amendments to the Annual Action Plan, both substantial and minor. Two amendments to the 2023-2024 Annual Action Plan were undertaken to include and allocate additional prior year CDBG funds (\$100,000) and HOME funds (\$220,000). The second amendment switched funding of one project from CDBG to HOME, and a second project to replace some of the HOME funding with CDBG. In summary, total funding was added or modified for the following projects/programs:

- The project: HOMES Homeowner Rehabilitation Program: received a net increase of \$220,000 in funding, including replacing \$80,000 of HOME funds with CDBG funds;
- Better Housing Coalition Carter Woods III: all allocated CDBG funds were replaced with HOME funds totaling \$300,000, including \$50,000 of prior year funds CDBG funds. The change in funds was necessary, as the project was new construction and would not to qualify for CDBG funds as the provider would not qualify as a CBDO.

• Cool Lane Apartments received an additional \$50,000 of CDBG funds to accommodate unexpected costs for sewer lines.

- Housing units produced using HOME funds are listed on the local MLS. CHDO housing producers market houses to their homebuyer classes which have high minority representation. CHDO Agreements, beginning in 2018-19 included specific language to ensure affirmative marketing.
- County staff provide presentations to community organizations on housing programs, including organizations representing and located in minority communities.
- Subrecipients place ads in newspapers serving Henrico County.
- Available HOME units are listed on subrecipients' and CHDOs' web pages.

HOME program income (PI) and homebuyer program funds (HP) in the amount of \$34,072.71 were received during PY 2023-24. A total of \$40,288.41 was expended (drawn) during PY 2023-24 as partial payment for two homeowner rehabilitation projects and one homebuyer assistance project. The IDIS activity numbers and owner characteristics for those projects are as follows:

- IDIS# 1469 HOME Inc. Homebuyer Assistance: Black/African American, 60% to 80% AMI, Non-Elderly, Single, One-Person Household using \$5,943.20 of HP funds.
- IDIS# 1470 project: HOMES Homeowner Rehab: Black/African American, Female Head of Household, 60% to 80% AMI, Elderly, Three-Person Household using \$272.50 of IU funds.
- IDIS# 1481 project:HOMES Homeowner Rehab: Black/African American, Female Head of Household, 0% to 30% AMI, Elderly, One-Person Household using \$8,811.00 of PI funds.
- IDIS# 1493 HOME Inc. Homebuyer Assistance: White, Female Head of Household, 60% to 80% AMI, Non-Elderly, One-Person Household using \$3,958.00 of HP funds.
- IDIS# 1515 project:HOMES Homeowner Rehab: Black/African American, Female Head of Household, 60% to 80% AMI, Elderly, One-Person Household using \$21,303.71 of PI funds.

The total amount of program income (PI) and homebuyer program (HP) funds expended/drawn during PY 2023-24 was \$40,288.41.

The CDBG-and HOME-funded projects completed during PY 2023-24 provided homebuyer assistance, minor home repairs, and moderate home rehabilitation. The projects fostered and maintained affordable housing in Henrico County for low- and moderate-income residents. In PY 2023-24, funds were provided that enabled the completion of 15 moderate rehabilitation projects, 57 critical home repair projects, and 23 down payment assistance grants. All of these programs and projects are ongoing and have been renewed with PY 2024-25 funds.

One proposed multi-family development in Henrico County received an allocation of competitive Low Income Housing Tax Credits for 53 housing units for new construction as an expansion to an existing project. This project, Carter Woods III, received an allocation of \$300,000 in PY 2023-24 to support this project.

The new Henrico County Housing Trust Fund was established in 2024 support the development of forsale housing for households less than 120% AMI.




