Preface

The County of Henrico is a recipient of federal Community Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) annual entitlement funds through the U. S. Department of Housing and Urban Development (HUD). A requirement of receiving these funds is to submit to HUD, within 90 days of the end of the program year, a report assessing progress in meeting the goals and objectives established in the Consolidated Plan and specific accomplishments and expenditures during the program year. The Henrico County program year is from October 1 to September 30.

The official submission of the Consolidated Annual Performance and Evaluation Report (CAPER) is provided to HUD through the online *eCon Planning Suite* in HUD's Integrated Disbursement and Information System (IDIS). Henrico County's CAPER submission occurred on December 27, 2016.

This document provides a printed version of information submitted to HUD through IDIS. This document is not the official submission, rather it is a compilation of the on-line information submitted, using a data exporting function provided by IDIS. Once exported, that information was subsequently reformatted to accommodate errors in in the IDIS export, to provide a more user-friendly document, and to make available key informational reports used by HUD in evaluating local government programs for the year. These reports are provided as attachments to this document. Beginning with the 2015-16 CAPER, data for persons served with ESG funds is no longer provided in Section CR-65, rather is developed through the ESG-CAPER annual reporting tool (e-Cart). Information generated through this tool is provided in an attachment.

Henrico County, Virginia major accomplishments for PY2015-16 include the following:

- Affordable housing was provided to 73 households through moderate home rehabilitation, minor home repairs, and down payment assistance.
- Homelessness prevention, case management, shelter, and rapid rehousing services were provided to 918 people .
- Public service programs providing after-school programs and home maintenance programs were provided to 234 people.
- Assistance was provided to a public facility serving over 100 low-income youth.
- Economic development assistance resulted in the creation of 20 new jobs for low-income persons.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

The preservation and development of affordable housing, community economic development, mitigation and prevention of homelessness, and non-housing community development are the four high priority needs identified in the 2015 Consolidation Plan. These priorities were addressed in 2015-16 through the following programs:

- Homeowner Rehabilitation. Ten homes were completed at a total cost of \$138,167.20 CDBG and \$348,253 HOME.
- Emergency and minor repairs to homes owned by low/moderate-income residents through project: HOMES. A total of 50 repairs were completed. Total CDBG cost of \$492,912.89.
- Development of new affordable housing through CHDOs. Four vacant homes and one vacant lot were purchased for the rehabilitation and/or construction of single-family dwellings for sale to low-income, first-time homebuyers in PY15-16. Total expenditure of HOME (CHDO) funds from prior program years PY 2010-2011 was \$57,831 and PY 2012-2013 was \$49,000 and PY 2014-2015 was \$17,224.09 and PY2015-2016 was \$27,600 for a total investment of \$151,655.09.
- Down payment and closing cost assistance through SCDHC to enable homeownership for lowincome first-time homebuyers. Funding was provided for seven homebuyers; five homebuyers were assisted.
- Down payment and closing cost assistance though HOME Inc. to enable homeownership for lowincome first-time homebuyers. Funding was provided for nine homebuyers; eight homebuyers were assisted.
- After-school substance abuse and violence prevention program through the CONNECT Program for at-risk youth and their parents residing in 11 low-income communities. Served 109 students throughout the program year. Total CDBG cost of \$160,184.
- The job creation and retention objective was accomplished through the creation of 20 new jobs (16 low-mod FTEs) through the Commercial Assistance, Enterprise Zone Façade Grant and Enterprise Zone Design Assistance programs. PY15-16 expenditures: \$210,167 CDBG. This results in an average of one job for every \$10,508 of CDBG expenditures for these programs.
- Completion of a playground at a facility serving low-income youth. 100 low-income children at the facility benefit from the playground which is located in a low/mod area and is also open to the public. Total CDBG cost of \$25,000.
- Completion of a series of workshops providing basic home maintenance skills to Henrico homeowners. 125 people participated. Total CDBG cost of \$10,000.
- Preliminary surveys and review process begun with Department of Historic Resources (DHR) in order to have the Highland Springs area potentially listed as a National Historic District. This was a cost-share grant with the Commonwealth of Virginia; \$17,500 of CDBG was matched with \$17,500 of state funds.
- The ESG program served 765 households/persons through homeless prevention services for a cost of \$21,500, 30 households/persons through rapid re-housing services for a cost of \$60,000 and 122 persons through case management and shelter services for a cost of \$45,000.

Narrative

CDBG and HOME funds investments for PY15-16 were primarily concentrated in the central to eastern portion of the County. Funds were not restricted to any area of the County. The six percent of funds for use in the target area of Highland Springs and Richmond International Raceway (renamed "Laburnum Gateway") areas was not expended during the program year.

Leveraging

Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.

The use of federal CDBG and HOME funds by Henrico County leveraged over \$3,034,532.27 in state, local, federal, and private funds (computed as total Nondepartmental budget plus HOME match contributed during current Federal fiscal year). It also generated an estimated 2,478 new jobs (*2015 Local Enterprise Annual Report to Virginia DHCD*).

Sources of leveraged funds included \$2,882,576 of PY 2015-2016 local funds from the Henrico County Nondepartmental budget and the budgets of the Departments of Building Inspections and Community Revitalization. Several agencies operate their programs in publicly-owned facilities or on publicly-owned lands.

As of August 2016, Henrico County is in year three of a three-year grant cycle for McKinney-Vento Homeless Assistance Act funds. We are also in the process of completing the grant application for the next 3-year cycle. Henrico County Public Schools received \$77,000 for the third year of the grant cycle, 2016-17. In 2015-16 HCPS received a 10% reduction (\$7,000) due to federal funding cuts, for a grant award of \$63,000. The \$77,000 award for 2016-17 reflects a return to the \$70,000 grant aware and a return of the \$7,000 reduction from last year. As of June 17, 2016 Henrico County served 817 homeless students.

As of November 2016, Henrico Area Mental Health & Developmental Services (HAMHDS) has 270 Housing Choice Vouchers under lease. The CVRC reported as of November 2016, 413 Housing Choice Vouchers currently in Henrico County and managed through an administrative services agreement with VHDA. RRS manages 185 vouchers for adults with intellectual disabilities and through the HUD-Veterans Affairs Supportive Housing (HUD-VASH) program. The specific number of these vouchers currently used in Henrico County is not available. The Richmond Redevelopment and Housing Authority also administers vouchers where households reside in Henrico County. The number of those is not available.

Henrico County's Department of Social Services (HDSS) created the Community Resource Unit (CRU) in 2010 to assist individuals facing difficulties in maintaining safe, stable and affordable housing. In the period of October 2015 to September 2016, the Community Resource Unit served 112 households. HDSS relies on the support of HEARTH of Henrico to provide homeless prevention assistance. Of the 112 total households served, 69 households were assisted with funds provided wholly or in-part by HEARTH between October 2015 and September 2016.

Table 11 --The above "one-year goal" numbers represent: 600 persons assisted through the YWCA hotline, 97 persons served with shelter, 69 persons served with rapid rehousing, or homelessness prevention for a total of 766; 78 households served through moderate rehabilitation, minor home repair, down payment assistance, and the production of new units; and one unit of special needs housing.

"Actual" numbers result from the following: 760 persons served thorugh YWCA hotline, 122 persons served with shelter, 30 persons served with rapid rehousing, six persons served with homelessness prevention for a total of 918; 50 households served with emergency or minor repair, 10 households served with moderate housing rehabilitation, 13 households provided downpayment assistance for a total of 73.

Table 12 -- The above 'Actual' numbers represent: 36 households provided rapid rehousing or homelessness prevention; 60 households provided with homeowner rehab or repair; and 13 down payment assistance grants for first-time homebuyers.

The one-year goal for special-needs households to be provided affordable housing is based on funding that was allocated to Virginia Supportive Housing for renovation of an SRO unit at New Clay House. The renovation will be completed in PY 2017. Rental assistance did not meet the goal as cost per household served was greater than expected and the goal includes homelessness prevention funded with CDBG funds (through a mid-year amendment) which will carry over into PY 2017. Although production of new units did not meet the goal, five properties were acquired for for this purpose and were in progress for completion in PY 2016. Acquisition of new units was less than projected due to sales not closing prior to the end of the program year for downpayment assistance grants in progress.

The impact on future annual action plans will be miniminal as program performance is closely monitored and when identified program adjustments are implemented to better align needs with limited resources.

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

During 2015-16 Henrico County funded eight non-profit corporations through the Non-Departmental component of the General Fund budget to prevent homelessness; provide case management, food and shelter for homeless individuals; provide supportive services for homeless and near-homeless individuals; and enable the transition to permanent housing. Services provided during 2015-16 were as follows:

- Hilliard House provided transitional housing and/or homeless prevention to 68 Henrico County families or individuals.
- CARITAS provided support services and emergency shelter to 46 Henrico individuals or families.
- Homeward provided assistance to service providers for support services, shelter, rapid rehousing, and homelessness prevention services benefitting 916 Henrico individuals or families.
- St. Joseph's Villa (Flagler Housing and Homeless Services) provided rapid rehousing services to 16 Henrico individuals or families.
- Salvation Army provided homelessness prevention services to 77 Henrico individuals or families.
- YWCA provided emergency safe housing, counseling, case management, transition housing, rapid rehousing, and/or financial assistance to 775 Henrico individuals or families.
- Resources for Independent Living provided services to 285 mentally and/or physically disabled Henrico individuals who were homeless or facing homelessness.
- Safe Harbor provided assistance to 1048 Henrico residents who were victims of sexual and/or domestic violence providing shelter, transitional housing, community counseling, court advocacy, and education programs.

Addressing the emergency shelter and transitional housing needs of homeless persons

Henrico County received funds for the PY2015-2016 year. The County utilized funding for the following ESG program components:

- Shelter
- Homeless Prevention
- Rapid Re-housing
- Data Collection (HMIS)
- Administration

Rapid Re-housing received 43.0% of the allocation, followed by Shelter which received 32.3% of the

allocation, Homeless Prevention received 15.4% of the allocation, and Data Collection (HMIS) received 1.8% of the allocation. ESG funds expended in PY2015 represent 99.7% of the total ESG grant funding in PY 2015.

The funds enabled homeless prevention activities for 766 persons, rapid-rehousing activities for 30 persons, and shelter for 122 persons. The allocation to four organizations helped Henrico County serve a total of 918 persons.

CDBG funds in the amount of \$40,000 were provided as part of a mid year amendment for homelessness prevention services. \$1,480 was expended in PY 2015.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Henrico County's Department of Social Services (HDSS) created the Community Resource Unit (CRU) in 2010 to assist individuals facing difficulties in maintaining safe, stable and affordable housing. Citizens who qualify for the program are offered housing stabilization services to help prevent low-income families and individuals from becoming homeless; assist families to locate safe and affordable housing provide home-based case management to facilitate client stabilization leading to self-sufficiency; providing short to medium term rental subsidies and encourage client accountability which promotes self-sufficiency. In the period of October 2015 to September 2016, the Community Resource Unit served 112 households.

HDSS relies on the support of HEARTH of Henrico to provide homeless prevention assistance. Of the 112 total households served, 69 households were assisted with funds provided wholly or in-part by HEARTH between October 2015 and September 2016.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Rapid Re-housing received 43.0% of the allocation, followed by Shelter which received 32.3% of the allocation, Homeless Prevention received 15.4% of the allocation and lastly Data Collection (HMIS) received 1.8% of the allocation and total ESG grant expended 99.7% of the funding in PY15.

30 households were provided Rapid Re-housing assistance to make the transition to permanent housing

and independent living.

Actions taken to address the needs of public housing

The County of Henrico has no public housing. Henrico County encourages affordable homeownership for low-income households through several programs. Specific actions during PY 2015-2016 to remove barriers and promote affordable housing include the following:

- Allocation of \$95,000 to HOME Inc for down payment and closing costs assistance and homeownership counseling, and a mid-year Action Plan amendment to provide an additional allocation of \$28,008, making total program allocation \$123,008.
- Allocation of \$95,000 to Southside Community Development and Housing Corporation for down payment and closing costs assistance and homeownership counseling.
- Allocation of \$495,000 to project: HOMES for Emergency & Minor Repairs program.
- Allocation of \$453,678 to project:HOMES for moderate home rehabilitation program, and a midyear Action Plan amendment to provide an to additional allocation of \$70,000, making total program allocation \$523,678.
- Allocation of \$241,000 for CHDO and other housing activities.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The County of Henrico has no public housing.

Actions taken to provide assistance to troubled PHAs

The County of Henrico has no public housing.

CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

Henrico County works in numerous ways to reduce the barriers to affordable housing. Building codes and tax policies are governed by state law and not subject to local adjustment but the County continues to provide an exemption from real estate taxes for low/moderate-income seniors and disabled homeowners. Henrico reduces barriers to residential development of all types by not requiring cash proffers. The real estate tax rate in Henrico County is among the lowest in the region, and the lowest of any large urban locality in Virginia. The Comprehensive Plan designates substantial area for residential development Henrico regularly approves new subdivisions and multi-family development for all income levels. In FY15-16, permits were issued for 757 new single family homes; 38 permits were issued for multi-family complexes.

An annual analysis undertaken in PY 2014 as part of the development of the 2015 Consolidated Plan and the 2015-16 Action Plan evaluated the opportunities for affordable housing for home purchasers and the availablilty of assisted housing in Henrico. That analysis determined that 62% of the single-family homes in the County were affordable for purchase by households earning up to 80% Area Median Income. The analysis also documented 2,239 project-based Section 8 units; 4,975 income-restricted apartment units supported by low income housing tax credits; and additional rent restricted units supported by tax exempt bond financing.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

While there are several constraints to meeting the needs of low-, very low-, and moderate-income residents, the primary obstacle is the lack of funding to fully address all needs. In response to the level of need, the County continued to provide local funding to nonprofits through the general fund non-departmental budget. The County, provided homeless prevention services and assistance for County residents, and continued on a County-wide basis to encourage economic development leading to job growth, much of which is targeted to low-, very low-, and moderate-income persons. Through the Henrico Area Mental Health and Development Services, the County continued to administer Housing Choice Vouchers for 270 families. The County also encouraged all types of residential development and has been supportive of the use of low-income housing tax credits for the rehabilitation of multi-family housing for low- and moderate-income persons. Henrico County supported the low-income housing tax credit application for an SRO expansion for supportive housing and provided PY2015 and PY2016 funding for that project.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

As referenced in the Annual Action Plan, Henrico County provides up to \$5,000 for lead-based paint assessment and abatement for homes receiving assistance through the moderate rehabilitation program.

All CDBG and HOME activities in Henrico County which involve the purchase or repair/renovation of houses built prior to 1978 follow federal lead-based paint regulations. During the implementation of these activities, appropriate steps are taken depending on the level of funding for the unit when lead-based paint is detected or presumed to be present. Subrecipient staff is trained on lead-based paint requirements (HUD Lead Safe Work Practice Certification; EPA Renovation, Repair and Painting Certification; and Healthy Homes for Community Health Worker Certification) and practices and each homeowner in a pre-1978 home is provided the EPA/HUD booklet "Protect Your Family From Lead in Your Home." Homeowners in repair/rehabilitation programs also receive the EPA booklet "The Lead-Safe Certified Guide to Renovate Right." A signature noting receipt of these documents is placed in each client file. Contractors used for repair/rehabilitation work are all EPA-certified under 40CFR Part 745.82 and 745.84. During PY 2015-16, 60 housing units were either made lead free or certified to be lead free following rehabilitation or repair work or were built after 1978.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

The Commercial Assistance Program, the Enterprise Zone Façade Grant program, and the Enterprise Zone Design Assistance program facilitate development and expansion of businesses to create jobs available to low- and moderate-income persons including persons in poverty.

The County will continue to support appropriate activities that preserve and expand the supply of housing that is affordable to low-income households. This will include support for applications for low-income housing tax credits for the rehabilitation of existing multi-family units which provides housing opportunities for low-and moderate-income persons. Two projects in Henrico County sought Low Income Housing Tax credits for the rehabilitation or new construction of housing units. One application was approved for 72 units of new affordable housing. Insufficient data are available to document the number of families County-wide that were removed from poverty during the program year.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The County has designated staff positions to administer the programs and activities funded with CDBG, HOME and ESG funds. Staff works with the individual County Departments, such as Public Works, Social Services, Recreation and Parks, Mental Health, Planning, Public Utilities, Building Inspections, Henrico County Public Schools, and the Division of Community Maintenance to develop procedures and coordination for administering programs that will be carried out by these divisions. Staff regularly tracks the production and effectiveness of all agencies, including subrecipients, tasked with implementing programs with CDBG, HOME, and ESG funds. PY 2015 was the second year of administering ESG funds and consequently County staff continued to build and foster relationships with homeless service providers and coordination agencies. Program staff began meeting and/or discussing program implementaiton, enhancements, and adjustments with these agencies. Of particular significance has been the particiation on committees of the Continuum of Care.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

Actions taken included:

- Continued participation as an active partner in the Richmond Region Continuum of Care, addressing homeless issues in the metropolitan area.
- Continued representation on the Richmond LISC Local Advisory Committee for the encouragement of affordable housing opportunities in the metropolitan area.
- Continued representation on the regional non-profit Partnership for Housing Affordability.
- Continued representation on the Economic Development Authority Business Retention Committee visiting businesses located in the Enterprise Zone to encourage job creation and commercial revitalization.
- Continued policy of no cash proffers for the development of new single-family houses to ensure greater affordability.
- Provided funds for down-payment and closing costs assistance to facilitate homeownership opportunities for low-income individuals.
- Continued the Real Estate Investment Tax Abatement program for houses assessed at \$250,000 or less in value to increase affordability.
- Community Development staff continued participation with the Richmond Community Development Alliance to discuss strategies to address local and regional housing issues, needs, and resources.
- Convened a monthly meeting of multiple County agencies (Resource Team) involved in addressing housing, social service, safety, and mental health needs of predominantly low-income Henrico residents.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

In September 2015, a consultant working for Henrico County completed a new *Analysis of Impediments to Fair Housing Choice*. That analysis identified impediments in five categories: Real Estate & Housing Market, Public Policy & Fair Housing Infrastructure, Banking, Finance & Insurance, Socioeconomic, and Neighborhood Conditions. Sixteen remedial actions were provided as recommendations to the County, some of which were provided as "conceptual frameworks" requiring further research. Impediments and actions taken during PY2015-16 are provided below:

- <u>Continue to support production of affordable housing through CHDO funds.</u> In PY15-16 Henrico County allocated \$141,000 for CHDO activities, an amount well in excess of the required setaside. An additional \$100,000 of CDBG was designated to support affordable housing in target areas.
- Support non-profit partners to facilitate access to below-market rate units. In PY15-16, Henrico County originally allocated HOME funds for 14 downpayment assistance grants for low-income first time homebuyers. That amount was increased in a mid-year amendment to facilitate 16 grants.
- 3. <u>Support non-profit partners that maintain relationships with lenders.</u> In PY15-16, three such partners were supported through funding.
- 4. <u>Support development and seek additional sources of funds for affordable housing.</u> No applicable opportunities for additional funding were identified during the year.
- 5. <u>Encourage private sector support for LIHTC and AHP.</u> Two projects applied for LIHTC support in Henrico. One received the credits; the other did not. Hernico will continue to work with the other project to help gain tax credits for 2017.
- 6. <u>Inadequate Awareness of Fair Housing Rights.</u> For PY16-17, Henrico County funded HOME, Inc. to undertake fair housing outreach and education in Henrico.
- 7. <u>Partner with local industry to conduct outreach and education regarding fair housing.</u> See item 6 above.
- 8. <u>Encourage Fair Housing Enforcement Agencies and HUD to increase fair housing testing.</u> These are ongoing activities of these agencies. HOME Inc. has a strong testing program in central Virginia.
- 9. <u>Expand Routes for Public transportation.</u> In 2015-16, Henrico County made a substantial financial commitment to the Broad Street Bus Rapid Transit that will extend into Henrico.
- 10. <u>Apply for funding for financial literacy.</u> This is an ongoing activity of several County agencies.
- 11. <u>Request the State to encourage lenders to offer assistance programs for households with</u> <u>predatory loans.</u> Informal discussions occurred in PY15-16. This is otherwise a continuing activity.

- 12. <u>Provide language assistance to persons with LEP.</u> Translation services are offered by several County agencies as needed.
- <u>Encourage recruitment of industry providing living wages.</u> The County's Economic Development Authority continuously recruits such employers. Henrico EDA reported 1,800 jobs added.
- 14. <u>Support Development that provides alternative housing choices.</u> In PY15-16 and PY16-17, a total of \$250,000 of CDBG funds were allocated towards the development of additional SRO units for homeless and disabled individuals.
- 15. <u>Support homeless prevention and rapid rehousing.</u> In PY15-16, a total of \$81,500 of ESG funds were allocated for these purposes. A Plan amendment allocated \$40,000 of CDBG funds for prevention.
- 16. <u>Continue Self-help programs.</u> The County continues its Operation Paintbrush and volunteer assistance programs and provided 2,034 hours of assistance in PY15-16

Over the course of the year Henrico County monitored each grant recipient once. Monitoring visits are attended by the representatives of the nonprofit staff, a representative from Henrico County's Department of Finance, and the HOME Program Manager for the CDBG, HOME, or ESG program as appropriate.

PY15-16 was the first year of ESG funding and all ESG subrecipients were monitored. Monitoring activities included a review of a sampling of program activities completed during the contract period. Each file was reviewed to ensure compliance with applicable standards as well as the approved project plans, environmental protection status, and marked in compliance with fair housing laws.

Monitoring results are provided in writing to subrecipients, first in draft form for review and comment. If adjustments to the report are needed, a final report is prepared including, as necessary, any identified findings or concerns along with any required or recommended corrective actions as appropriate.

County staff continuously reviewed eligibility documentation for compliance with applicable program regulations including client eligibility, proposed property improvements, need for service, and annual audit reports conducted by an outside third party certified accounting firm.

All funding recipients are required to submit monthly reports detailing the status of all activities throughout the program year. County staff reviewed each monthly report for financial and programmatic accuracy and program progress.

Notice of the availability of a draft annual performance report is published in the Richmond Times-Dispatch. Citizens are given 15 days to review and provide comment on the document. An April 2016 amendment reallocated ESG funds from homelessness prevention to the Hilliard House Emergency Shelter.

- All housing units produced using HOME funds are listed on the local MLS. CHDO housing producers market houses to their homebuyer classes which have high minority representation.
- County staff annually provides presentations to approximately 25 community organizations on County housing programs, including the availability of new HOME units. These include organizations representing and located in minority communities.
- Subrecipients place ads in newspapers serving Henrico County.

\$86,566.80 of HOME program income was received in PY15. These funds were used to partially assist in the completion of four homeowner rehabilitation projects (IDIS Activity Number 1108, 1111, 1112, & 1113) and three down payment assistance grants (IDIS Activity Number 1106, 1110, & 1119). The owner characteristics are as follows: the homeowner rehabilitation project (IDIS Activity Number 1108) assisted a very low-income (50-60% of Area Median Income), elderly White citizen; the homeowner rehabilitation project (IDIS Activity Number 1111) assisted an extremely low-income (30-50% of Area Median Income), elderly Black/African American citizen; the homeowner rehabilitation project (IDIS Activity Number 1112) assisted an extremely low-income (30-50% of Area Median Income), elderly Black/African American citizen; the homeowner rehabilitation project (IDIS Activity Number 1112) assisted an extremely low-income (30-50% of Area Median Income), elderly White citizen; and the homeowner rehabilitation project (IDIS Activity Number 1113)) assisted an extremely low-income (30-50% of Area Median Income), elderly Black/African American citizen. The CDBG- and HOME-funded projects comapleted during PY15 provided down payment assistance, minor home repairs, and moderate home rehabilitation. The projects fostered and maintained affordable housing in Henrico County for low- and moderate-income residents. In PY15 funds were provided for the completion of ten moderate rehabilitation projects, 50 minor repairs projects, and 13 down payment assistance projects. All of these programs and projects are ongoing and will be renewed with PY16-17 funds. Two projects in Henrico County sought Low Income Housing Tax credits for the rehabilitation or new construction of housing units. One application was approved for 72 units of new affordable housing. The County supported the other project through processing a request for a Revitalization Area designation that would have provided additional points on the tax credit application.

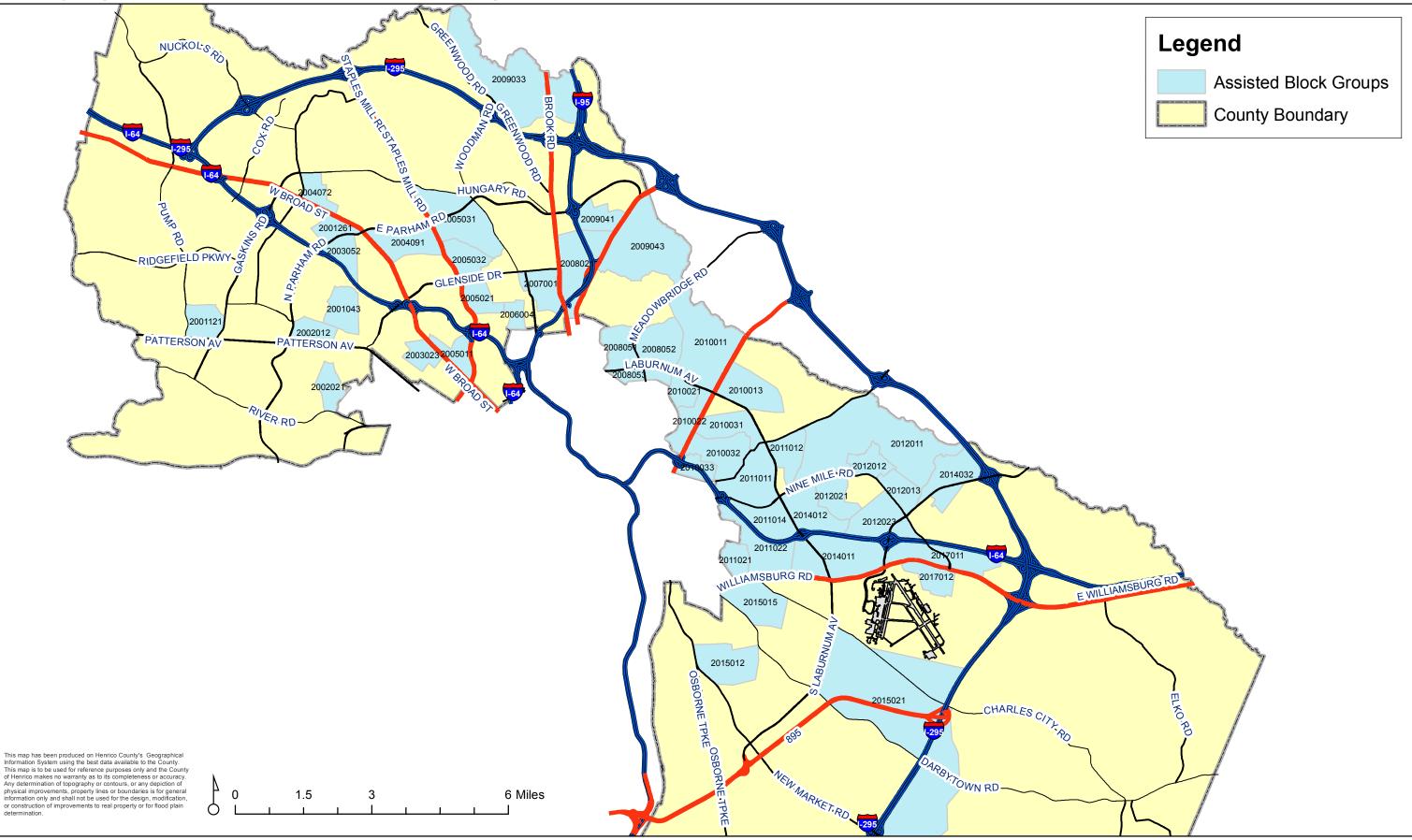
