Preface

The County of Henrico is a recipient of federal Community Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) annual entitlement funds through the U. S. Department of Housing and Urban Development (HUD). A requirement of receiving these funds is to submit to HUD, within 90 days of the end of the program year, a report assessing progress in meeting the goals and objectives established in the Consolidated Plan and specific accomplishments and expenditures during the program year. The Henrico County program year is from October 1 to September 30.

The official submission of the Consolidated Annual Performance and Evaluation Report (CAPER) is provided to HUD through the online *eCon Planning Suite* in HUD's Integrated Disbursement and Information System (IDIS). Henrico County's CAPER submission occurred on December 27, 2017.

This document provides a printed version of information submitted to HUD through IDIS. This document is not the official submission, rather it is a compilation of the on-line information submitted, using a data exporting function provided by IDIS. Once exported, that information was subsequently reformatted to accommodate errors in in the IDIS export, to provide a more user-friendly document, and to make available key informational reports used by HUD in evaluating local government programs for the year. These reports are provided as attachments to this document. Beginning with the 2016-17 CAPER, data for persons served with ESG funds is no longer provided in Section CR-65, rather is developed through the Sage HMIS Reporting repository. A report from that system is provided directly to HUD. A copy of the report generated by that system is provided in the Appendix of this document.

Henrico County, Virginia major accomplishments for PY2016-17 include the following:

- Affordable housing was provided to 79 households through moderate home rehabilitation, minor home repairs, development of new affordable housing, and down payment assistance.
- Homelessness prevention, case management, shelter, and rapid re-housing services were provided to 893 people*.
- Public service programs providing after-school programs, home maintenance workshops, and fair housing counseling or outreach were provided to 518 people.
- Economic development assistance resulted in the creation of 14 new jobs for low-income persons.
- * The number of persons served differs from the total provided through the HUD Sage reporting system and itemized elsewhere in this CAPER. The 893 number represents only those served with Henrico County ESG funds. Sage reports are based on data in the HMIS system which includes persons served from sources other than Henrico County ESG funds. Data in this CAPER on accomplishments resulting from the expenditure of ESG funds may be reported by either persons, households, or a combination of the two.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

The preservation and development of affordable housing, community economic development, mitigation and prevention of homelessness, and non-housing community development are the four high priority needs identified in the 2016 Consolidation Plan. These priorities were addressed in 2016-17 through the following programs:

- Homeowner Rehabilitation. Nine homes were completed at a total cost of \$66,096 CDBG and \$418,725 HOME.
- Emergency and minor repairs to homes owned by low/moderate-income residents through project: HOMES. A total of 55 repairs were completed. Total CDBG cost of \$515,000.
- Development of new affordable housing through CHDOs. Three vacant homes were purchased for the rehabilitation and/or construction of single-family dwellings for sale to low-income, first-time homebuyers in PY16-17. Total expenditure of HOME (CHDO) funds from prior program years PY 2010-2011 was \$57,831, PY 2012-2013 was \$49,000, PY 2014-2015 was \$17,224.09, PY2015-2016 was \$27,600 and PY2016-2017 was \$98,000 for a total investment of \$249,055.09.
- Down payment and closing cost assistance through SCDHC to enable homeownership for lowincome first-time homebuyers. Funding was provided for seven homebuyers; six homebuyers were assisted.
- Down payment and closing cost assistance though HOME Inc. to enable homeownership for low-income first-time homebuyers. Funding was provided for nine homebuyers; seven homebuyers were assisted.
- After-school substance abuse and violence prevention through the CONNECT Program for at-risk youth and their parents residing in 11 low-income communities. Served 137 students throughout the program year. Total CDBG cost of \$156,127.13.
- The job creation and retention objective was accomplished through the creation of 24 new jobs (14 low-mod FTEs) through the Commercial Assistance, Enterprise Zone Façade Grant and Enterprise Zone Design Assistance programs. PY16-17 expenditures: \$248,500 CDBG. This results in an average of one job for every \$17,750 of CDBG expenditures for these programs.
- Completion of a series of workshops providing basic home maintenance skills to Henrico homeowners. 147 people participated. Total CDBG cost of \$9,121.11.
- Continuation of survey work in cooperation with the Virginia Department of Historic resources to enable the listing of Highland Springs in the National Register of Historic Places resulted in the completion of 600 architectural surveys. An expenditure of \$67,500 was incurred in PY 2016-17.
- The Henrico ESG program served 733 households/persons through homeless prevention services for a cost of \$20,932.02, 46 persons through rapid re-housing services for a cost of \$39,000 and 114 persons (27 by Housing Families First; 87 by CARITAS) through case management and shelter services for a cost of \$55,250.

Narrative

CDBG and HOME funds investments for PY16-17 were primarily concentrated in the central to eastern portion of the County. Funds were not restricted to any area of the County. Six percent of the funds for the target area of Highland Springs and Richmond International Raceway (renamed "Laburnum Gateway") areas were not expended during the program year.

Leveraging

Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.

The use of federal CDBG and HOME funds by Henrico County leveraged over \$3,034,532.27 in state, local, federal, and private funds (computed as total Nondepartmental budget plus HOME match contributed during current Federal fiscal year). It also generated an estimated 2,478 new jobs (2016 Local Enterprise Annual Report to Virginia DHCD). Sources of leveraged funds included \$2,882,576 of PY 2016-2017 local funds from the Henrico County Nondepartmental budget and the budgets of the Departments of Building Inspections and Community Revitalization. Several agencies operate their programs in publicly-owned facilities or on publicly-owned lands. Agencies supported are as follows:

Effective August 2017, Henrico County Public Schools was awarded another 3-year grant under the McKinney-Vento Homeless Education Assistance Act. The award amount was \$68,000 for

each of the years in the 3-year grant cycle, starting in fiscal year 2017-18 and continuing through year 2019-2010.

As of June 16, 2017 Henrico County served 991 homeless students in the 2016-17 school year, an increase of 174 students over the previous year. HCPS also receives general financial support in the form of 'set-aside' funds through our Federal Programs office. The combined funds allow for financial support of 991 homeless students. As of November 2017, Henrico Area Mental Health & Developmental Services (HAMHDS) has 273 Housing Choice Vouchers under lease. The CVRC reported as of November 2017, 414 Housing Choice Vouchers currently in Henrico County and managed through an administrative services agreement with VHDA. RRS manages 185 vouchers through the HUD VASH program, approximately 10 of which are used in Henrico County. The specific number of these vouchers currently used in Henrico County is not available. The Richmond Redevelopment and Housing Authority also administers vouchers where households reside in Henrico County. That number is also not available.

Henrico County's Department of Social Services' (HDSS) Intake & Community Resource Unit (ICRU) performs intake functions for both Child Protective Service and Adult Protective Services. ICRU also responds to emergency needs requests by providing information and referral services, homelessness prevention, homelessness diversion, and in rare incidences will provide emergency shelter.

Table 11 -- The "one-year goal" numbers shown above represent: 135 persons served with shelter, 867 persons served with rapid re-housing, or homelessness prevention for a total of 1,002; 82 households served through moderate rehabilitation, minor home repair, down payment assistance, and the production of new units; and one unit of special needs housing.

"Actual" numbers result from the following: 731 persons served through YWCA hotline (homeless prevention), 114 persons served with shelter, 46 persons served with rapid re-housing, 5 persons served with homelessness prevention (with both ESG and CDBG funds) for a total of 896; 56 households served with emergency or minor repair, 9 households served with moderate housing rehabilitation, 13 households provided downpayment assistance, and one household provided affordable housing through CHDO developed projects, for a total of 79. Two households also benefited from CHDO-produced housing but also received downpayment assistance.

The special needs housing goal was not met as the provider has had delays in beginning construction of the project. Homeless prevention funds were not fully spent due to staffing limitations, and program guidelines that limit access to ESG funds.

Given the success with the homeowner repair and rehabilitation programs, little change is expected. Performance of all programs is closely monitored so that mid-year program adjustments and reallocations can be made.

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

During 2016-17 Henrico County funded eight non-profit corporations through the Non-Departmental component of the General Fund budget to prevent homelessness, provide case management and food and shelter for homeless individuals, provide supportive services for homeless and near-homeless individuals and families, and enable the transition to permanent housing. Services provided during 2016-17 were as follows:

- Housing Families First provided emergency shelter and/or rapid re-housing to 89 families or individuals (as reported through HCIS).
- CARITAS provided support services and emergency shelter to 659 individuals (as reported through HCIS), 87 of which were Henrico residents.
- Homeward provided assistance to service providers for support services, shelter, rapid rehousing, and homelessness prevention services benefitting 667 Henrico individuals or families.
- YWCA provided emergency safe housing, counseling, case management, transition housing, rapid re-housing, and/or financial assistance to 727 Henrico individuals or families. (as reported through HCIS)

Addressing the emergency shelter and transitional housing needs of homeless persons

Henrico County received funds for the PY2016-2017 year. The County utilized funding for the following ESG program components:

- Shelter
- Homeless Prevention
- Rapid Re-housing
- Data Collection (HMIS)
- Administration

Shelter received 38.95% of the allocation followed by, Rapid Re-housing received 27.49% of the allocation, Homeless Prevention received 14.76% of the allocation and Data Collection (HMIS) received 1.76% of the allocation. 91.05% of the PY 2016 ESG grant was expended during the Program Year. The funds enabled homeless prevention activities for 731 persons/households, rapid re-housing activities for 46 persons/households, and shelter for 114 persons.

CDBG funds in the amount of \$40,000 were provided to the Department of Social Services during PY 2015 for homelessness prevention services and \$3,762.17 was spent in PY 2016.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Henrico County's Department of Social Services (HDSS) created the Intake & Community Resource Unit (ICRU) in 2010 to assist families and individuals in crisis. ICRU performs intake functions for both Child Protective Service and Adult Protective Services. ICRU also responds to emergency needs requests by providing information and referral services, homelessness prevention, homelessness diversion, and in rare incidences will provide emergency shelter. Citizens and agencies will contact ICRU for a wide variety of emergency needs that can include housing, utilities, food, clothing, and medical. A trained staff person will conduct a brief assessment, will discuss how to engage informal supports, will share information about existing community resources, and will problem solve with the individual to identify solutions. For those who qualify we provide case management along with short term rental and utility assistance with the goals of promoting safe and stable housing and improving self-sufficiency. In the period from October 1, 2016 to September 30, 2017, the Intake & Community Resource Unit completed 1712 Child Protective Services referrals, 899 Adult Protective Services referrals, and 955 screening requests. HDSS also responded to 5792 emergency needs requests, and provided financial assistance to 141 households.

HDSS relies on the support of HEARTH of Henrico to provide homeless prevention assistance. Of the 141 total households who received financial assistance, 90 households were served with funds provided wholly or in-part by HEARTH of Henrico.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Shelter received 38.95% of the allocation followed by, Rapid Re-housing received 27.49% of the allocation, Homeless Prevention received 14.76% of the allocation and lastly Data Collection (HMIS) received 1.76% of the allocation and total ESG grant expended 91.05% of the funding in PY16.

The funds enabled homeless prevention activities for 731 persons/households, rapid-re-housing activities for 46 persons/households, and shelter for 114 persons. The allocation to four organizations helped Henrico County serve a total of 896 persons/households.

Actions taken to address the needs of public housing

The County of Henrico has no public housing. Henrico County encourages affordable homeownership for low-income households through several programs. Specific actions during PY 2016-2017 to remove barriers and promote affordable housing include the following:

- Allocation of \$95,000 to HOME Inc for down payment and closing costs assistance and homeownership counseling, and a mid-year Action Plan amendment to provide an additional allocation of \$42,693, making total program allocation \$137,693.
- Allocation of \$78,500 to Southside Community Development and Housing Corporation for down payment and closing costs assistance and homeownership counseling.
- Allocation of \$495,000 to project:HOMES for Emergency & Minor Repairs programand a midyear Action Plan amendment to provide an additional allocation of \$20,000, making total program allocation \$515,000.
- Allocation of \$484,821 to project:HOMES for moderate home rehabilitation program.
- Allocation of \$98,000 for CHDO activities to create new affordable housing.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The County of Henrico has no public housing.

Actions taken to provide assistance to troubled PHAs

The County of Henrico has no public housing.

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

Henrico County works in numerous ways to reduce the barriers to affordable housing. Building codes and tax policies are governed by state law and not subject to local adjustment but the County continues to provide an exemption from real estate taxes for low/moderate-income seniors and disabled homeowners through the Real Estate Advantage Program (REAP). Henrico reduces barriers to residential development of all types by not requiring cash proffers. The real estate tax rate in Henrico County is among the lowest in the region, and among large urban localities in Virginia. The Comprehensive Plan designates substantial area for residential development and Henrico County regularly approves new subdivisions and multi-family development for all income levels. In FY16-17, permits were issued for 789 new single family homes; 75 permits were issued for multi-family complexes.

The Analysis of Impediments to Fair Housing Choice, prepared by a consultant independent from Henrico County and completed in September 2015, identified no impediments to fair housing choice resulting from the negative effects of public policies.

A biannual analysis undertaken in PY 2016 as part of the development of the 2016 Consolidated Plan and the 2016-17 Action Plan evaluated the opportunities for affordable housing for Henrico home purchasers. That analysis determined that 55% of the single-family homes in the County were affordable by households earning up to 80% Area Median Income. if available for purchase. This is a decrease from 2015 when 62% fell into this category. This change is attributable primarily to the increase in assessed housing values, still reflecting a rebound of the 2008 crash in the housing market.

Within the rental housing market, there are 2,303 units supported by project-based housing choice vouchers or equivalent, providing housing opportunities for very low income households. There are also 3,664 additional rental units supported by low income housing tax credits; and additional rent restricted units supported by tax exempt bond financing.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

While there are several constraints to meeting the needs of low-, very low-, and moderate-income residents, the primary obstacle is the lack of funding to fully address all needs. In response to the level of need, Henrico County continued to provide local funding to non-profit agencies through the general fund non-departmental budget. The County provided homeless prevention services and assistance for County residents, and continued on a County-wide basis to encourage economic development leading to job growth, much of which is targeted to low-, very low-, and moderate-income persons. Through the Henrico Area Mental Health and Development Services, the County continued to administer Housing Choice Vouchers for 257 families. The County also encouraged all types of residential development and has been supportive of the use of low-income housing tax credits for the rehabilitation of multi-family housing for low- and moderate-income persons. In March 2017, the County Board of Supervisors approved a resolution designating a Revitalization Area in support of the low-income housing tax credits

tax credit application for the development of 120 units of affordable rental housing. Henrico County continued its support for the expansion of a supportive housing SRO through 2016-17 CDBG funding. That project is expected to begin construction in December 2017.

Among the greatest needs has been addressing the condition of existing housing of low income homeowners. During PY 2016, 65 households received housing repair or rehabilitation assistance through the County's program partners. This program has been expanded for 2017 with an additional provider.

To encourage and provide opportunities for new low and moderate income homebuyers, downpayment and closing cost assistance was provided to 13 households.

While the supported project did not receive a tax credit allocation, an additional project received an allocation in calendar year 2017 for the new construction of housing 54 units

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

As referenced in the Annual Action Plan, Henrico County provides up to \$5,000 for lead-based paint assessment and abatement for homes receiving assistance through the moderate rehabilitation program.

All CDBG and HOME activities in Henrico County which involve the purchase or repair/renovation of houses built prior to 1978 follow federal lead-based paint regulations. During the implementation of these activities, appropriate steps are taken depending on the level of funding for the unit when lead-based paint is detected or presumed to be present. Subrecipient staff is trained on lead-based paint requirements (HUD Lead Safe Work Practice Certification; EPA Renovation, Repair and Painting Certification; and Healthy Homes for Community Health Worker Certification) and practices and each homeowner in a pre-1978 home is provided the EPA/HUD booklet Protect Your Family From Lead in Your Home. Homeowners in repair/rehabilitation programs also receive the EPA booklet "The Lead-Safe Certified Guide to Renovate Right." A signature noting receipt of these documents is placed in each client file. Contractors used for repair/rehabilitation work are all EPA-certified under 40CFR Part 745.82 and 745.84. During PY 2016-17, 68 housing units were either made lead free or certified to be lead free following rehabilitation or repair work or were built after 1978.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

The Commercial Assistance Program, the Enterprise Zone Façade Grant program, and the Enterprise Zone Design Assistance program facilitate development and expansion of businesses to create jobs available to low- and moderate-income persons including persons in poverty.

According to the 2015 and 2016 American Community Survey 1-Year Estimates, looking at 125% of the poverty level, 5,994 persons were removed from poverty during this time. More recent data are not available to evaluate reductions in the number of poverty level persons or families during the program year.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The County has designated staff to administer the programs and activities funded with CDBG, HOME and ESG funds. Staff works with the individual County Departments, such as Public Works, Social Services, Recreation and Parks, Mental Health, Planning, Public Utilities, Building Inspections, Henrico County Public Schools, and the Division of Community Maintenance to coordinate the administration of programs that will be carried out by these agencies. Staff regularly tracks the production and effectiveness of all agencies, including subrecipients, tasked with implementing programs with CDBG, HOME, and ESG funds. PY 2016 was the third year of administering ESG funds and consequently County staff continued to build and foster relationships with homeless service providers and coordinating agencies. Program staff began meeting and/or discussing program implementation, enhancements, and adjustments with these agencies. Of particular significance has been the participation on committees of the Continuum of Care.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

Actions taken included:

- Continued participation as an active partner in the Richmond Region Continuum of Care, addressing homeless issues in the metropolitan area.
- Continued representation on the Richmond LISC Local Advisory Committee for the encouragement of affordable housing opportunities in the metropolitan area.
- Continued representation on the regional non-profit Partnership for Housing Affordability.
- Continued representation on the Economic Development Authority Business Retention
 Committee visiting businesses located in the Enterprise Zone to encourage job creation and commercial revitalization.
- Continued policy of no cash proffers for the development of new single-family houses to ensure greater affordability.
- Provided funds for down-payment and closing costs assistance to facilitate homeownership opportunities for low-income individuals.
- Continued the Real Estate Investment Tax Abatement program for houses assessed at \$250,000 or less in value to increase affordability.
- Community Development staff continued participation with the Richmond Community
 Development Alliance to discuss strategies to address local and regional housing issues, needs, and resources.
- Convened a monthly meeting of multiple County agencies (Resource Team) involved in addressing housing, social service, safety, and mental health needs of predominantly lowincome Henrico residents.
- Participated in the bi-monthly meeting of the Richmond Community Development Alliance fostering coordination among Richmond area housing non-profits and the three entitlement jurisdictions.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

In September 2016, a consultant working for Henrico County completed a new *Analysis of Impediments to Fair Housing Choice*. It identified five categories of impediments with sixteen remedial actions recommended to the County, some as "conceptual frameworks" for further research. Impediments & actions taken during PY2016-17 are provided below:

- 1. Continue to support production of affordable housing with CHDO funds. In PY16-17 Henrico County allocated \$98,000 for CHDO activities.
- 2. Support non-profit partners to facilitate access to below-market rate units. In PY16-17, Henrico County originally allocated HOME funds for 14 downpayment assistance grants for low-income first time homebuyers. That amount was increased in a mid-year amendment to facilitate 18 grants.
- 3. Support non-profit partners that maintain relationships with lenders. In PY16-17, three such partners were supported through funding.
- 4. Support development and seek additional sources of funds for affordable housing. No applicable opportunities for additional funding were identified during the year. A single request for financial support for a multi-family development was withdrawn when the project was denied a low income housing tax credit allocation. Additional funding in the amount of \$200,000 was provided to support the development of a supportive housing SRO.
- 5. Encourage private sector support for LIHTC and AHP. One projects applied for LIHTC support in Henrico. It received support through a Board of Supervisors resolution designating a Revitalization Area.
- 6. Inadequate Awareness of Fair Housing Rights. For PY16-17, Henrico County funded HOME, Inc. to undertake fair housing outreach and education in Henrico. Additional funding was provided for 2017-18
- 7. Partner with local industry to conduct outreach and education regarding fair housing. See item 6 above.
- 8. Encourage Fair Housing Enforcement Agencies and HUD to increase fair housing testing. These are ongoing activities of these agencies. HOME Inc. has a strong testing program in central Virginia.
- 9. Expand Routes for Public transportation. In 2016-17, Henrico County made a substantial financial commitment to the Broad Street Bus Rapid Transit (the "Pulse") that will extend into Henrico County and is expected to be operational in spring 2018.
- 10. Apply for funding for financial literacy. This is an ongoing activity of several County agencies.
- 11. Request the State to encourage lenders to offer assistance programs for households with predatory loans. Informal discussions occurred in PY16-17. This is otherwise a continuing activity.
- 12. Provide language assistance to persons with LEP. Translation services are offered primarily through the services of Language Line for translation. In 2016-17 HOME Inc. focused much of its CDBG-funded fair housing outreach to immigrant communities, participating in World Refugee Day, Spanish language radio ads, and housing brochures in multiple languages.
- 13. Encourage recruitment of industry providing living wages. The County's EDA continuously recruits such employers. According to the Quarterly Census of Employment and Wages, between December 2015 and December 2016 (the most current 12-month period for which data are available) 946 (net) jobs were added.

- 14. Support Development that provides alternative housing choices. In PY16-17 and PY16-17, a total of \$250,000 of CDBG funds was allocated towards the development of additional SRO units for homeless and disabled individuals.
- 15. Support homeless prevention and rapid re-housing. In PY16-17, a total of \$73,500 of ESG funds were allocated for these purposes
- 16. Continue self-help programs. The County continues its Operation Paintbrush and volunteer assistance programs, providing 5,162 hours of assistance in PY16-17

Over the course of the year Henrico County monitored CDBG, HOME, and ESG grant recipients. Monitoring visits are attended by the representatives of the nonprofit staff, a representative from Henrico County's Department of Finance, and the Program Manager for the CDBG, HOME, or ESG program as appropriate.

PY16-17 was the third year of ESG funding and all ESG subrecipients were monitored. Monitoring activities included a review of a sampling of program activities completed during the contract period. Each file was reviewed to ensure compliance with applicable standards as well as the approved project plans, environmental protection status, and marked in compliance with fair housing laws.

Monitoring results are provided in writing to subrecipients, first in draft form for review and comment. If adjustments to the report are needed, a final report is prepared including, as necessary, any identified findings or concerns along with any required or recommended corrective actions as appropriate.

County staff continuously reviewed eligibility documentation for compliance with applicable program regulations including client eligibility, proposed property improvements, need for service, and annual audit reports conducted by an outside third party certified accounting firm.

All funding recipients are required to submit monthly reports detailing the status of all activities throughout the program year. County staff reviewed each monthly report for financial and programmatic accuracy and program progress.

Notice of the availability of a draft annual performance report is published in the Richmond Times-Dispatch. Citizens are given 15 days to review and provide comment on the document. No comments were received during the 15-day comment period.

The amendment incorporated unspent funds from PY 2015-16, allocating \$20,000 of CDBG funds to the Emergency and Minor Repair Program with project:HOMES, allocating \$10,000 of HOME funds to project:HOMES to facilitate acquisition of vacant houses for affordable housing development by CHDOs, and allocating an additional \$42,693 of HOME funds for homebuyer assistance through Housing Opportunities Made Equal.

- Housing units produced using HOME funds are listed on the local MLS. CHDO housing producers

- County staff annually provides presentations to approximately 25 community organizations on County housing programs, including the availability of new HOME units. These include organizations representing and located in minority communities.
- Subrecipients place ads in newspapers serving Henrico County.

\$22,387.20 of HOME program income was received in PY16. The funds were used to partially assist in the completion of a homeowner rehabilitation project (IDIS Activity Number 1156). The owner characteristics are as follows: the homeowner rehabilitation project (IDIS Activity Number 1156) assisted a very low-income (0-30% of Area Median Income) household, a two person household, and an elderly Black/African American citizen.

Describe other actions taken to foster and maintain affordable housing. 91.220(k) (STATES ONLY: Including the coordination of LIHTC with the development of affordable housing). 91.320(j)

The CDBG- and HOME-funded projects completed during PY16 provided down payment assistance, minor home repairs, and moderate home rehabilitation. The projects fostered and maintained affordable housing in Henrico County for low- and moderate-income residents. In PY16 funds were provided for the completion of nine moderate rehabilitation projects, 56 minor repairs projects, and 15 down payment assistance projects. All of these programs and projects are ongoing and will be renewed with PY17-18 funds. One proposed multi-family developent in Henrico County sought Low Income Housing Tax credits for the construction of new housing units. Although the County supported the project through processing a request for a Revitalization Area designation, the project ultimately did not receive a tax credit allocation. The project also requested CDBG and HOME funding to assist with project financing, however that request was withdrawn upon denial of the tax credit allocation by VHDA.

11. Project Outcomes Data measured under the performance standards developed in consultation with the CoC(s)

The data below provide totals and averages for agencies provided ESG funding by Henrico County based on all clients served (not just those identifying as being from Henrico).

The Greater Richmond Continuum of Care adopted performance measures for 2017, three of which are applicable to programs funded with Henrico County ESG funds. The HMIS staff run APR reports quarterly for review by the funded agencies and provides this information to the Project Development Manager. With the exception of providers primarily serving survivors of domestic violence, all programs use HMIS to collect data and monitor program outcomes. Measures and outcomes are as follows:

- Exits to permanent destinations: 54.7%
- Average length of stay (system leavers): 44 days
- Returns to homelessness (after exit to permanent destination): 5.0%

The Greater Richmond Continuum of Care (GRCoC) tracks HEARTH Act system level performance measures for the U.S. Department of Housing and Urban Development and the Virginia Department of Housing and Community Development. In addition, the GRCoC board regularly seeks public comments and reviews the system performance measures and indicators developed by the GRCoC Performance Measurement and Ranking Committees.

The system level performance measures and project level performance measures are used to review and rank applications for federal and state funding for homeless services. ESG staff participates in this ranking and review process. The GRCoC Ranking Committee advises all entitlement jurisdictions within the CoC on performance and alignment with community goals. In 2015 and 2016, the CoC worked with Focus Strategies to complete the Base Year Calculator which uses HEARTH measures to review and monitor system performance. This tool is used by the Ranking and Performance Measurement Committees to monitor and enhance progress on system level outcomes.

Overall, the number of people experiencing homelessness in the CoC has been consistently decreasing since the peak in 2009. From 2016 to 2017, the point-in-time number decreased by 13.1% to 662 people experiencing homelessness in the GRCoC. Between 2015 and 2016, the Annual Homelessness Assessment report has shown increases in the annual number of people in families served in emergency shelter (up 18.7%), the number of single adults served in emergency shelter (up 2.1%), and the number

of single adults served in transitional housing has slightly decreased (up 8.0%). While the larger number of individuals served combined with decreasing point-in-time counts indicate success in reducing lengths of stay, the GRCoC is working through the Coordinated Entry Committee to ensure that all persons served by emergency shelter are literally homeless or have no other housing options. The Shelter Diversion Line and work to improve the existing coordinated entry programs will contribute to this goal.

The community continues to make progress in reducing the number of people who experience homelessness in our community. The CoC uses the Homeless Management Information System (HMIS) to report on HEARTH outcomes and provides data for CAPER reports.

Figure 1. County of Henrico Areas of Investment of CDBG and HOME Funds for Program Year 2016-17


