
The County of Henrico Department of Public Works welcomes you to the Public Information Meeting for the proposed Hilliard Road Safety and Mobility Improvements project. The purpose of this meeting is to provide an opportunity for citizens or organizations to provide comments on the proposed project. The County wants all members of the community to have the opportunity to participate in public involvement on projects affecting them. County staff will address all questions and concerns raised as a result of this Public Information Meeting.

Project Description

The Hilliard Road Safety and Mobility Improvements project entails approximately 0.5 miles of bicycle and pedestrian improvements to improve safety and connectivity along Hilliard Road in the Lakeside area. The restriping of Hilliard Road will occur from Lakeside Avenue to the proposed Fall Line Trail (Lakeside Phase 3) / Fall Line Trail (Brook & Hilliard). The restriping of Hilliard Road will revise the four-lane roadway to a two-lane roadway with a center turn lane and protected bicycle lanes in both eastbound and westbound lanes. Pedestrian safety enhancements will be constructed at the proposed crossing of the Fall Line Trail. The re-configuration of vehicular travel lanes along this stretch of Hilliard Road is supported by Kittleson and Associate's traffic study data that was commissioned by VDOT in 2018. This data has since been verified by Henrico OCunty in 2022.

Project Overview

Location: From Lakeside Avenue to the Fall Line Trail (Lakeside – Phase 3)/ Fall Line Trail (Brook & Hilliard)

Length: 0.5 miles

Purpose: To increase bicycle and pedestrian access along Hilliard Road by improving safety and connectivity

Anticipated Cost: ~\$200,000

Anticipated Schedule: Design:

Design:May 2023 – August 2023Construction:October 2023 – February 2024

Environmental Review

The project will be developed in compliance with all applicable regulations, and measures will be taken to minimize any potential environmental impacts. All required environmental clearances and permits will be obtained prior to commencement of construction. During construction, all reasonable efforts will be made to protect the environment with respect to dust control, siltation, and erosion. Construction will conform to the County's specifications and special provisions and the Virginia Department of Soil and Water Conservation regulations.
