A *Final Report of Special Inspections* documenting completion of specified special inspections, correction of any discrepancies, and observed code violations noted in the inspection and testing reports shall be submitted to and approved by Henrico County Department of Building Inspections prior to the issuance of a Certificate of Occupancy.
