INSTRUCTIONS A Virginia registered design professional or a qualified inspector shall complete all portions of this form. The form shall be signed and sealed by the Virginia registered design professional that performed the inspection. If a qualified inspector completes the form, it shall be signed and sealed by the Virginia registered design professional that is responsible for supervision of the qualified inspector. The building permit and the County approved plans shall be provided to the qualified inspector or registered design professional at the time of the inspection. Prior to the inspection, the Virginia registered design professional is required to notify the Department of Building Construction and Inspections that they have been Employed to perform the footing inspection. Pursuant to the Virginia Uniform Statewide Building Code, this inspection report, the Virginia registered design professional, and the qualified inspector are subject to the review and approval of the Henrico County Department of Building Construction and Inspections. Submission of the completed form to Henrico County is certification by the registered design professional that the footing conforms to the Virginia Uniform Statewide Building Code and the construction plans have been approved by Henrico County and all applicable County codes and ordinances.
