

# **SKATE PARK RULES & REGULATIONS**

### Know your ability and use accordingly. This is an unsupervised facility. Use at your own risk.

The County of Henrico does not assume responsibility for any injury. Skateboarding, biking, in-line skating at this facility are hazardous recreational activities. Use of this facility may expose the user to serious injury.

- The skate park has been designed for all skill levels.
- Please take turns on the bowls and be courteous to other people using the facility.
- Only skateboards, bicycles, non-motorized equipment, in-line, and roller skates are permitted.
- Helmets are always required. Kneepads, elbow pads, and wrist guards are highly recommended.
- Closed toe shoes must be worn at all times.
- Inspect the surfaces before you begin; remove any trash, debris or objects that may prevent a smooth, safe ride.
- No use permitted when wet, raining, in icy conditions or during routine maintenance periods. Users may not salt, wax, or sand any portion of the park.
- Additional ramps, jumps, obstacles are not permitted in the skate park. No modifications to the skating surface or features are permitted. No skating on park structures not specifically designed for that purpose.
- Graffiti, tagging, littering, stickers or other items are prohibited. Graffiti/vandalism of the skate park will result in a minimum 24-hour facility closure.
- Organized events require the prior approval of Henrico Recreation & Parks.
- The County of Henrico is not responsible for lost or stolen items.
- Anyone who does not adhere to these rules may be banned from Taylor Farm Park by the Director of Henrico Recreation & Parks.
- Report any damage/hazardous conditions to Henrico Recreation & Parks at (804) 501-7275. Report illegal activity to Henrico Division of Police at (804) 501-5000. For an emergency, call 911.

### **Prohibited:**

Food or Drinks (except water) • Glass Containers • Smoking • Drugs and Alcohol • Pets

Tandem Riding • Reckless Behavior • Horseplay or Roughhousing

Loitering inside Skate Park • Skating or Riding Outside of Skate Park Area

Motorized equipment including battery-powered wheeled devices (except those used with an accessible device)



## **BMX DIRT SKILLS COURSE RULES & REGULATIONS**

- The BMX course has been designed for all skill levels.
- Please take turns on the course and be courteous to other people using the facility.
- BMX bicycles only.
- Helmets are always required. Gloves, kneepads, and elbow pads are highly recommended.
- Ride only in designated areas.
- No use is permitted when wet, raining, icy conditions, during routine maintenance periods, or when closed signs are posted.
- Users may not alter or modify any portion of the park.
- Organized events require the prior approval of Henrico Recreation & Parks.
- The County of Henrico is not responsible for lost or stolen items.
- Anyone who does not adhere to these rules may be banned from Taylor Farm Park by the Director of Henrico Recreation & Parks.
- Report any damage/hazardous conditions to Henrico Recreation & Parks at (804) 501-7275. Report illegal activity to Henrico Division of Police at (804) 501-5000. For an emergency, call 911.
