NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that:

- (1) The County Manager is authorized to execute an assignment and assumption agreement in a form approved by the County Attorney, to assume existing leases on the Property; and,
- (2) The County Manager and the County Attorney are authorized to undertake all other actions necessary to complete the assignment and assumption of the leases by the County; and,
- (3) Upon the County's acquisition of title to the Property and the assumption of the leases, the County Manager is authorized and directed to execute any future amendments on behalf of the County, in forms approved by the County Attorney, for the leasing of the Property.
