ORDER OF PUBLICATION

The object of this suit is to forfeit to the Commonwealth of Virginia a 2017 Mercedes, VIN WDCYC7DF3HX266479, because said property was used in substantial connection with, or were proceeds derived from, or were purchased with proceeds derived from, the illegal manufacture, sale or distribution of controlled substances or the possession with intent to distribute controlled substances in violation of Section 18.2-248 et seq., of the Code of Virginia, 1950, as amended. This is a civil action for forfeiture pursuant to Sections 19.2-386.1 and 19.2-386.22, Code of Virginia, 1950, as amended. IN THE ALTERNATIVE, this seizure took place due to the fact that said property was used in substantial connection with, or were traceable proceeds of some form derived from, the illegal laundering of proceeds of some activity punishable as a felony under the laws of this Commonwealth in violation of Section 18.2-246.3 and 19.2-386.19 of the Code of Virginia, 1950, as amended.


The above styled property was seized pursuant to a seizure warrant issued on September 8, 2021. Personal Service was obtained on Defendant Nikike Namar Tyler, and he has already forfeited his interest in the 2017 Mercees, VIN WDCYC7DF3HX266479. Upon an affidavit filed, it appears that the whereabouts of Defendants Tierra Chavonte Haskins and Yao Wang are

unknown, and that due diligence has been used by the Plaintiff, the Commonwealth of Virginia, to ascertain their location. Tierra Chavonte Haskins's last known address is 2026 E. Main Street, Apt. 304, Richmond, VA 23223. Yao Wang's last known address is 28 Neal Path, Centereach, NY 11720. Therefore, it is ORDERED that Plaintiff's request for an electronic Order of Publication is granted; and it is further

ORDERED that defendants Tierra Chavonte Haskins and Yao Wang, or any other party claiming interest in such property, appear in the Circuit Court for the County of Henrico, Virginia, on or before January 15, 2026, at 2:00 p.m., to protect their interest in said property; and it is further

ORDERED that this Order of Publication be published once a week for four (4) successive weeks on the Henrico Circuit Court website, and that a copy of this order be posted at the front door of the Circuit Court of Henrico County, Virginia. A copy of this order is to be mailed to Defendants Tierra Chavonte Haskins and Yao Wang at their last known addresses given in the affidavit of the Plaintiff filed herein. It is further ORDERED by the undersigned judge to dispense with publication of this order in a newspaper. Upon completion of the publication on the Henrico Circuit Court website, the Clerk shall file a certificate stating that all the requirements of §8.01-317 have been completed. A copy of this Order shall be given to the Commonwealth.

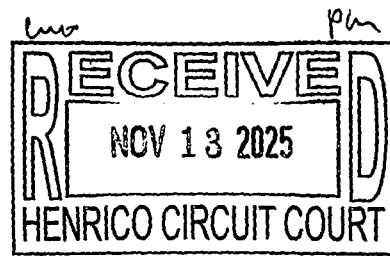
