Summary of Actions Taken by the Board on March 27, 1996

The invocation was given by Mr. Quille Boone, Chaplain, Henrico County Jail.

The minutes from the March 8, 1996 Regional Meeting and the March 13, 1996 Board of Supervisors Regular and Special meetings were approved.

MANAGER'S COMMENTS

Judy Davis Poore, who holds the position of Auditor II with the Office of Internal Audit, has been named one of the ten "Volunteers of the Year" in Virginia by the Credit Union Association. She was selected from among the hundreds of volunteers serving credit unions in the Richmond Chapter area.

Col. Henry W. Stanley, Chief of Police, recognized twenty individuals within the Division of Police who have just completed community policing training. Sixteen officers who were in attendance were personally introduced to the Board of Supervisors. Col. Stanley also presented the members of the Board with a booklet containing the telephone and pager numbers of each of the Community Police officers.
