# PUBLIC HEARING - PROVISIONAL USE PERMITS AND REZONING CASES:

**Approved** -- Request of Dumbarton Properties for Bruce D. Perretz for approval of a provisional use permit in accordance with Sections 24-58.2 (d) and 24-122.1 of Chapter 24 of the County Code in order to allow outdoor dining for an existing restaurant located within the Staples Mill Shopping Center. The outdoor dining facility would be located on part of Parcel 82-A-21B, located at the northwest quadrant of the intersection of Staples Mill Road and Glenside Drive.

**Approved** -- Request of Cellular One of Richmond for approval of a provisional use permit in accordance with Sections 24-95 (a)(3) and 24-122.1 of Chapter 24 of the County Code in order to construct and operate a 150' communications tower and related facilities on Parcel 59-A-12E, located at 2551 Homeview Road.

**Approved With Amended Proffers** -- Request of Glenn R. Moore for Dominion Land and Development Partnership to conditionally rezone from A-1 Agricultural District to R-2AC One Family Residence District (Conditional), Parcels 9-A-5 and 9-A-29, being 15.57 acres fronting 1093.27' on the east line of Pouncey Tract Road (S.R. 271) beginning 65' from the south line of Old Wyndham Drive. A single family subdivision is proposed.

**Approved** -- Request of Jay M. Weinberg for Opus East, L.L.C. to amend proffered conditions accepted with rezoning case C-74C-94 on Parcels 47-4-A-2, 47-4-A-1A, 37-3-A-1B, Brookhollow, Section 1, located at the northeast and northwest corners of Brookriver Drive and W. Broad Street.

**Approved With Amended Proffers** -- Request of Kenneth G. Magalis for Special Marketing, Inc. to conditionally rezone from A-1 Agricultural District to M-1C Light Industrial District (Conditional), Parcels 130-2-1-1 and 130-2-1-1A being 16.21 acres fronting 500.81' on the north side of Creighton Road approximately 1,750' east of Cedar Fork Road. An office/warehouse and other unspecified uses are proposed.

**Approved With Amended Proffers** -- Request of Henry L. Wilton for Wilton Development Corporation to conditionally rezone from A-1 Agricultural District to R-4C One-Family Residence District (Conditional), Parcels 43-A-46 and 53-A-1 being 17.39 acres fronting 546.18' on the east side of Telegraph Road, south of Telegraph Road's intersection with Pennsylvania Avenue.

**Approved** -- Request of Delmonte Lewis for Barrington Brooke Company to conditionally rezone from A-1 Agricultural District to R-3C One Family Residence District (Conditional), part of Parcel 46-0A-21, being 19.3 +- acres, fronting 1197.97' on the south line of relocated Three Chopt Road beginning 160' +- north of the terminus of Longview Landing Court. A single family subdivision is proposed.

**Deferred to June 12, 1996 Board Meeting** -- Request of Glenn R. Moore for Duma and Associates, L.C. to conditionally rezone from O-2C Office District (Conditional) to M-1C Light Industrial District (Conditional) Parcel 48-A-70B, being 1.443 acres located at the northwest intersection of Stillman Parkway and Mayland Drive. An automobile repair facility is proposed.
