Summary of Actions Taken by the Board on November 26, 1996

The minutes of the November 13, 1996 Regular and Special Meetings were approved.

MANAGER'S COMMENTS

County Manager Virgil R. Hazelett, P. E., announced that the Lewis Ginter Botanical Garden at Bloemendaal had been selected by the County's Historic Preservation Advisory Committee (HPAC) as this year's recipient of the annual Henrico County Historic Preservation Award. Mr. Hazelett recognized Dr. Henry Nelson, HPAC Chairman, who was joined by Recreation and Parks Director Wes Malcomb in presenting the award to Lewis Ginter's Executive Director, Frank Robinson, and its Director of Development, Marcia Horwitz.

Paul N. Proto, Director of General Services, was one of four Virginia local government officials appointed earlier this year by Governor George Allen to serve an inaugural term on the nine-member Design-Build/Construction Management Review Board established by the Virginia General Assembly during the 1996 Session. Named in 1983 as the Commonwealth's Purchaser of the Year, Mr. Proto's appointment by the Governor and recent election as the Review Board's first chairman reflects his broad experience in competitive sealed bidding, competitive negotiation, and design build/construction management procedures.
