## Summary of Actions Taken by the Board on June 12, 2001

The invocation was given by Reverend Robert L. Boggs, Pastor, Hunton Baptist Church.

The minutes of the May 22, 2001 Regular and Special Meetings were approved.

### MANAGER'S COMMENTS

As part of the Association of Metropolitan Sewerage Agencies' (AMSA) Peak Performance Awards, AMSA has awarded its Gold Award to the Henrico Water Reclamation Facility (WRF), managed by Mark Prentice, for consistently meeting all National Pollutant Discharge Elimination System (NPDES) permit limits during the 2000 calendar year.

Gary Aheimer, a Chemist at the WRF's laboratory, was awarded the Water Environment Federation's (WEF) Lab Analyst Award for 2000 at the Virginia Water Environment Association's (VWEA) Annual Meeting in May. Carol Isenhour, Chief of Laboratory Operations, was elected President of VWEA at this meeting.

Virginia Supreme Court Chief Justice Harry L. Carrico has invited County Attorney Joseph P. Rapisarda, Jr. to join the faculty for the Virginia State Bar professionalism course, which all newly licensed Virginia lawyers must take within one year of their admission to the bar. Mr. Rapisarda will serve a three-year term, beginning in December and running through December 2004.

### PUBLIC COMMENTS

Milton D. Drummond, Jr., a resident of the Tuckahoe District, reiterated his opposition to residential subdivision covenants that restrict the display of the United States flag, which he previously conveyed to the Board at its May 23, 2000 meeting. He also expressed concerns about the outcome of a recent local court case addressing this issue.
