Summary of Actions Taken by the Board on December 10, 2002

The minutes of the November 26, 2002 Regular and Special Meetings, November 19, 2002 Special Meeting and March 18 - 22, 2002 Special Meeting were approved.

MANAGER'S COMMENTS

Mr. Hazelett recognized County government Christmas Mother Program Chair, Barbara Poole of the County Manager's Office, and her Co-Chair, Nancy Drumheller of the Department of Public Utilities. Mrs. Poole, joined by Mrs. Drumheller, presented a ceremonial check in the amount of \$8,050 to the 2002 Henrico County Christmas Mother, Betty Lyon, and noted the large volume of non-cash contributions on display in the Board Room that had been collected from County employees. Sheriff's Office employees received a special acknowledgment for personally donating 48 bicycle helmets and 63 new bicycles that were assembled by trustees of the Henrico correctional system.

Linda B. Jones, Administrative Assistant and Deputy Clerk to the Board of Supervisors, has earned the prestigious designation of Certified Municipal Clerk (CMC), which is awarded by the International Institute of Municipal Clerks (IIMC) to local government clerks and deputy clerks who have met high educational, experience, and service requirements. In attaining certification, Mrs. Jones completed 100 hours of in-depth coursework over a three-year period at the Certified Municipal Clerk Institute administered by Old Dominion University's Center for Global Business and Executive Education.

The Henrico Division of Police recently received an award from the National Association of Town Watch for the County's successful National Night Out program, which is a community effort involving the Division's Special Services Unit, the Henrico County Neighborhood Watch Council, and local citizens. Only 30 such awards were given nationwide in the population category in which Henrico competed.

Capt. Phillip Childrey of the Sheriff's Office, a Master Sergeant in the United States Army's elite Special Forces (Green Berets) since 1964, recently returned to Henrico County after serving a tour of duty in the Bosnia-Herzegovina area of the former Yugoslavia Republic. In recognition of Capt. Childrey's exceptional service as Sergeant Major from November 13, 2001 to October 8, 2002, the U. S. Department of Defense has awarded him with its fifth highest award for merit, the Defense Meritorious Service Award. Additionally, Capt. Childrey has received the Armed Forces Expeditionary Medal and the NATO Service Medal. Capt. Childrey is one of 15 members of the Sheriff's Office who have taken military leave to serve their country since September 11, 2001.

Mr. Hazelett noted the passing on December 8, 2002 of John W. "Jack" Mootz, who retired from the County of Henrico in 2000 as Superintendent of the Juvenile Detention Home. Mr. Hazelett noted that the funeral service would be held in South Hill on December 11 and that Mr. Mootz would be missed deeply by the County staff.
