PUBLIC COMMENTS

Sam Godzwa, a resident of the Tuckahoe District, voiced concerns regarding the new noise ordinance. He explained he is a musician who practices his drums at home during the daytime. He has tried to accommodate his neighbors as much as possible and be considerate, but he has still received complaints. He requested the Board reconsider the daytime noise ordinance or to make amendments to allow music to be practiced in residential areas during the daytime for certain hours or at certain decibel levels.
