## RESOLUTION - Establishing the Henrico County Sustainability and Resilience Advisory Committee and Appointing Initial Members.

This Board paper establishes the Sustainability and Resilience Advisory Committee ("SRAC") to advise the Board of Supervisors on environmental sustainability and resilience matters. The following members of the County Manager's Henrico Environmental Action Resource Team ("HEART") Committee are appointed as the initial members of SRAC for terms ending December 31, 2025: Josh Byerly, Adam Girard, Kim Edmonds, Barbara Salas, Geoff Weidele, Eric Byers, Matt Chafin, Zach Harwood, Ryan Levering, Ashley Austin, Alex Gruendl, David Swing, Steve Yob, Rosemary Deemer, and Sam Hudson. The initial members will establish bylaws for SRAC governing the conduct of meetings and the election of officers.

After the terms of the initial members, SRAC will consist of (i) 10 voting members who will be appointed to serve at the pleasure of the Board for one-year terms and compensated at the rate of \$200 for each meeting attended, and (ii) the chairs of the subcommittees of the HEART Committee who will serve as non-voting, *ex officio* members without compensation.

## RESOLUTION - Signatory Authority - Quitclaim of Utility Easement - 5701 Eastport Boulevard - Varina District.

This Board paper authorizes the Chair to execute a quitclaim deed releasing any interest the County may have in a 16' utility easement on 5701 Eastport Boulevard. A replacement utility easement had been conveyed to the County, and the County no longer needs the first easement.

The Real Property Division has processed this request through the Departments of Planning, Public Works, and Public Utilities without objection. The Director of Real Property recommends approval of the Board paper; the County Manager concurs.

## ORDINANCE - Vacation of Portion of Drainage and Utility Easement - 4411 Sarellen Road - Richmond Industrial Interport - Varina District.

This ordinance would vacate a portion of a drainage and utility easement on property used by KSB, Inc., a leading supplier of pumps and industrial valves. The property owners have requested the vacation to accommodate expansion of their business warehouse. County facilities are not needed in the area of the easement to be vacated.

The Real Property Division has processed this request through the Departments of Planning, Public Works, and Public Utilities without objection. The Director of Real Property recommends approval of the Board paper; the County Manager concurs.

# RESOLUTION - Signatory Authority - Acquisition of Real Property for Drainage Mitigation - 3809 Francistown Road - Brookland District.

This Board paper authorizes the acquisition of an undeveloped parcel of land located at 3809 Francistown Road for drainage mitigation for the surrounding residents. The owners, Doris and Kerry Scruggs, have agreed to sell the property to the County for \$2,990.

The Directors of Public Works and Real Property recommend approval of the Board paper; the County Manager concurs.

## RESOLUTION - Signatory Authority - Improvements, Maintenance, and Parking Agreement - Fall Line Trail - 10425 Greenwood Road - Fairfield District.

This Board paper authorizes the County Manager to execute an Improvements, Maintenance, and Parking Agreement with the Central Virginia Soccer Association. The Association is a non-profit, adult soccer league that owns and operates the Longdale Recreation Center. The County will improve and maintain the Center's parking lot, and the Association will allow visitors to the Fall Line Trail to use the parking lot.

The Directors of Public Works and Real Property recommend approval of this Board paper; the County Manager concurs.

## **RESOLUTION** - Signatory Authority - Abandonment and Quitclaim of Portion of Old Pump Road - Three Chopt District.

This Board paper would abandon and quitclaim right-of-way known as Old Pump Road, near the intersection of John Rolfe Parkway, Pump Road, and Church Road and adjacent to a parcel of vacant land owned by Bradford Homes, Inc. The County right-of-way is unimproved and not necessary for public transit. Bradford Homes, Inc., has requested the abandonment and quitclaim in connection with the development of the neighborhood known as the Preserve at John Rolfe (Section 1).

The Real Property Division has processed the requested vacation through the Departments of Planning, Public Works, and Public Utilities without objection. The Director of Real Property recommends approval of the Board paper; the County Manager concurs.

## RESOLUTION - Signatory Authority - Award of Contract - Annual Contract for New Water and Sewer Service Line Installations.

This Board paper awards a unit price contract to Walter C. Via Enterprises, Inc. for new water and sewer service line installation on private property. The contract consists of providing new water and sewer service line installation in Henrico County.

The County received one bid on July 9, 2025, in response to ITB No. 24-2789-12EAR and Addenda Nos. 1 and 2.

The bid was as follows:

Bidder Bid Amount

Walter C. Via Enterprises, Inc. West Point, VA

\$6,936,000

Based upon a review of the bid, Walter C. Via Enterprises, Inc. is the lowest responsive and responsible bidder.

The contract will be for a period of one year, with the option for the County to renew the contract for up to two additional one-year terms.

The cost of each project assigned under contract will be determined upon completion of that project by multiplying the unit quantities authorized by the County by the unit prices submitted in the contractor's bid.

This Board paper awards the contract to Walter C. Via Enterprises, Inc. and grants signatory authority to the County Manager to execute the contract in a form approved by the County Attorney. The County Manager, or the Purchasing Director as his designee, is authorized to execute change orders within the scope of the project budget.

## RESOLUTION - Signatory Authority - Construction Change Order - Tuckahoe Creek Trunk Sewer - Phase I - Three Chopt District.

On June 11, 2024, the Board of Supervisors approved a construction contract with Godsey & Son, Inc. in the amount of \$2,637,625 to construct approximately 4,560 linear feet of 16-inch and 20-inch sanitary sewer main from Kain Road to Bacova Drive.

This Board paper authorizes the County Manager to execute a change order for the project in the amount of \$855,750 due to unforeseen conditions that require additional excavation of rock.

Funding will be provided by the Water and Sewer Revenue Fund. The Directors of Public Utilities and Purchasing recommend approval of this Board paper, and the County Manager concurs.
