METHODOLOGY FOR THE 2024 ADULT HOUSING REPORT

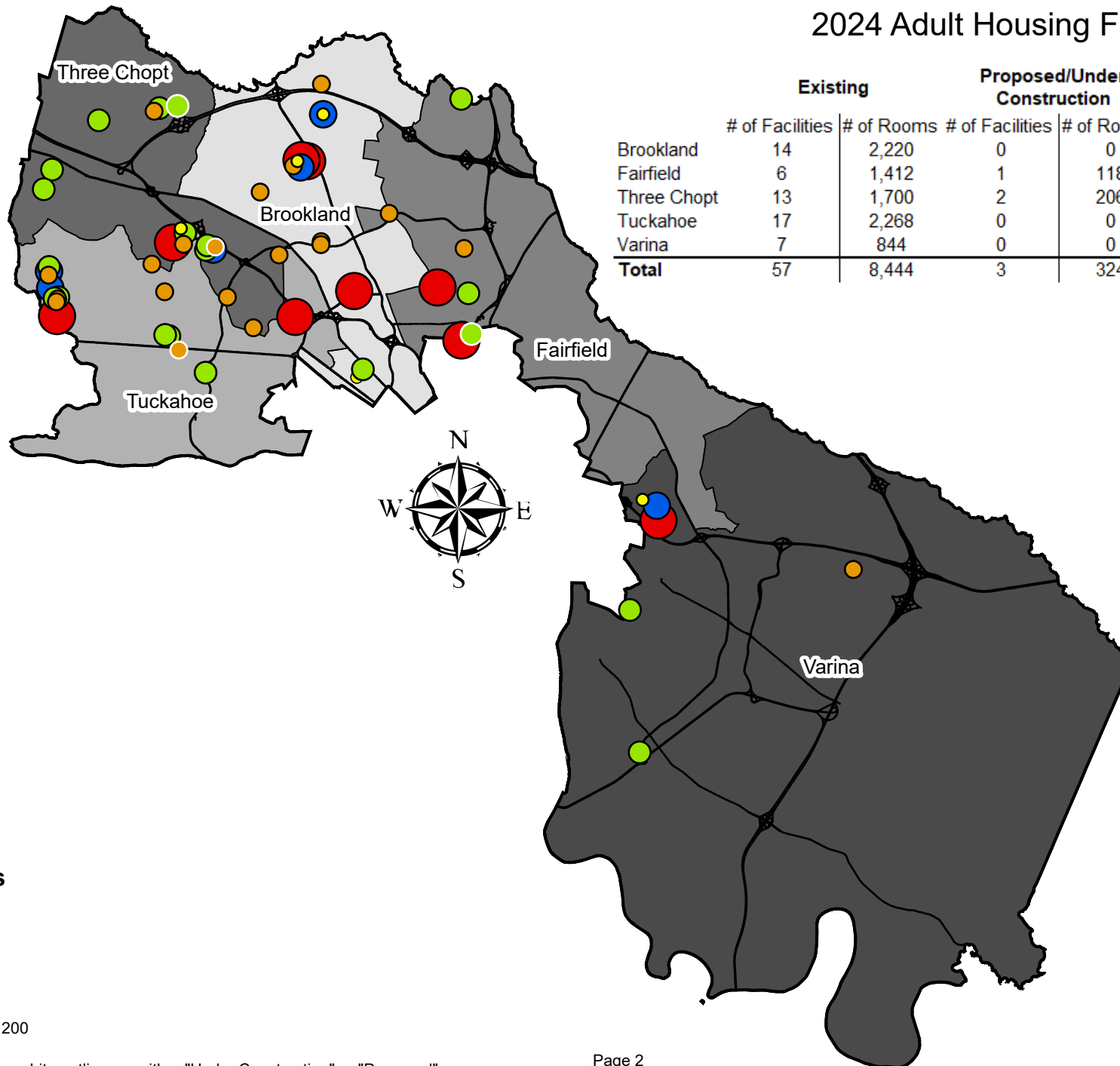
The Adult Housing Report is a summary of all housing facilities in Henrico County that provide services exclusively to the adult population (usually those aged 55 or greater). Information is from a variety of sources including the County's real estate database, approved Plans of Development (POD), and GIS. The report categorizes the housing facilities into four different types: Assisted Living, Health Care, Independent Living, and Alzheimer's Care. Furthermore, the report is broken down into two sections. The first provides information on all facilities (including those listed as "Proposed" or "Under Construction"), while the second section provides more detailed information solely on the "Existing" facilities. A map is available at the beginning of the report to identify the general location of all Adult Housing Facilities and their status.

The report, itself, identifies several key points of information regarding each Adult Housing Facility:

 - o GPIN (Geographic Parcel Identification Number)
 - o Total # of Units
 - o Type of Facility (as explained above)

 - o Amenities (second part)
